RULING # 99

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) TRAINER LARRY ALTERMAN IS HEREBY SUSPENDED FOR A PERIOD OF FORTY FIVE (45) DAYS AUGUST 03, 2009 THROUGH SEPTEMBER 17, 2009. ADDITIONALLY TRAINER LARRY ALTERMAN IS FINED THE SUM OF FIVE (\$500.00)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843.6 (D) (1,2) (TOTAL CARBON DIOXIDE TESTING – TC02 [39.3 MILLIMOLES PER LITER] CLASS III) IN EXCESS OF PERMITTED LEVEL. LARRY ALTERMAN WAS THE TRAINER OF RECORD FOR THE HORSE “FROLOV” WHO FINISHED SEVENTH IN THE FIFTH RACE ON JULY 17, 2009 AT CAL-EXP HARNESS RACING, SACRAMENTO, CALIFORNIA.

TWO HUNDRED FIFTY (\$250.00) DOLLARS OF THE FINE SHALL BE STAYED FOR ONE (1) YEAR WITH THE RESPONDENT PLACED ON PROBATION FOR A PERIOD OF ONE (1) YEAR BEGINNING AUGUST 03, 2009 AND ENDING ON AUGUST 02, 2010, SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS OF PROBATION:

- (A) DURING THE PERIOD OF PROBATION, LARRY ALTERMAN MUST NOT BE IN VIOLATION OF CHRB RULES AND REGULATIONS, SECTIONS 1843, 1843.6 AND 1887.
(B) IF THE RESPONDENT VIOLATES A CONDITION OF HIS PROBATION, THE ABOVE-REFERENCED STAY SHALL BE LIFTED, AND THE REMAINING AMOUNT SHALL BE IMPOSED AFTER NOTICE AND HEARING.

\*California Horse Racing Board rule # 1532 states that all fines shall be paid to the paymaster of purses within seven (7) days of imposition or the license of the person upon whom the fine was imposed shall be suspended.

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF LARRY ALTERMAN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1528 (JURISDICTION OF STEWARDS) LARRY ALTERMAN IS HEREBY DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.
