RULING #4 SILVIO AMADOR

Ruling #4

Jockey **Silvio Amador** who rode **Iowa Hawkeye** in the second race at Golden Gate Fields on Sunday, January 2, 2022, is fined the sum of Five Hundred Dollars (\$500.00)* for violation of California Horse Racing Board Rule #1688 (Use of Riding Crop-used more than six times).

The Stewards met with Jockey **Silvio Amador** for a review of his ride in **Iowa Hawkeye** in the second place on January 2, 2022.

After a review of the video **Mr. Amador** acknowledged he used his riding crop seven times during the race.

INQUIRY – 7TH RACE – NO CHANGE

The Stewards posted the Inquiry sign following the seventh race for a review of an incident approaching the finish line.

#5 **Better Tomorrow (Pedro Terrero)** second was injured while in front near the finish and #2 **Philipie Fast (Irving Orozco)** fourth, ran up on and steadied behind the injured leader.

The Stewards decided, in a majority vote, to make no change in the original order of finish. Steward Baker dissented, voting to place #5 **Better Tomorrow** fourth.

The Stewards were informed by Pari-Mutuel Manager **Douglas Gooby** that the Laurel Park signal indicated they had accepted wagers on their third race, the race had run, and the results were official.

The problem was Laurel Park had cancelled their program due to inclement weather and inserted a track (San Isidro) from Buenos Aires, Argentina, in its place.

The Stewards advised **Mr. Gooby** to discontinue accepting wagers from the Laurel Park signal which in fact were on races from Argentina that had not been approved or even requested.

The Stewards have informed **Mr. Gooby** that letters of explanation from him, Am-Tote International and Laurel Park are expected. This Board of Stewards has requested an investigation by the California Horse Racing Board.
