**WEDNESDAY**1/26/22<sup>1</sup>**DUTY STEWARD**

Stewards **Baker**, **Lewis** and **Nevin** were present to address a California Horse Racing Board Complaint filed against **Demesio Camacho** by Investigator **Jerry Smith**, alleging violation of California Horse Racing Board Rules #1874, #1490(a) (8), and #1900. **Mr. Camacho** failed to appear for today's scheduled hearing. More to come.

1/27/22<sup>3</sup>**TRAINER JACQUI M. NAVARRE (21GG0092)**

Trainer **Jacqui M. Navarre** appeared before the Board of Stewards for a tape recorded hearing to address a complaint filed against her alleging violation of California Horse Racing Board Rules #1843 (a) & (d), #1843.1 (b), #1844 (d) (3), #1842.5 and #1887 (a). California Horse Racing Board Investigator **Jerry Smith** presented the case and after evidence and testimony were submitted for the record, the hearing was concluded. Decision Forthcoming.

**RULING #16 – DEMESIO CAMACHO (REFER 1/27/22)**

The following Ruling was issued as **Mr. Camacho** failed to appear for his scheduled hearing on January 27, 2022.

**Ruling #16**

Groom **Demesio Camacho** having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before January 27, 2022, is suspended for violation of California Horse Racing Board Rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer to charges alleging violation of California Horse Racing Board Rule #1874 (Disorderly Conduct- Marijuana).

**AMENDED RULING #5 – SIMON CALLAGHAN**

The Stewards issued an amended Ruling that cited Trainer **Simon Callaghan** for a medication violation (Methocarbamol- in excessive permitted level). The original Ruling inadvertently indicated a Class three violation and is corrected to read a Class four violation.

**JULIEN COUTON, ELADIO CAMANCHO AND DARLENE LA ROCHELLE**

Jockey **Julien Couton**, Exercise Rider **Eladio Camancho** and Exercise Rider **Darlene La Rochelle** responded to a report by Outrider **Ashton Compoy** citing their actions while the horse ambulance was entering or actually on the track during morning training.

Jockey **Couton** and his mount were completing a half mile work when they passed the quarter mile chute as the horse ambulance was about to enter the track to attend to a horse pulled up near the 3/8 pole. **Mr. Camancho** and **Ms. La Rochelle** were galloping their mounts in the middle of the track as the horse ambulance was already on the scene and they did shift down to the inside rail after sight of the ambulance which was on the outside rail at the elbow of the 3/8 turn.

**Mr. Compoy** agreed with the accounting of the incident and did note that one of the warning lights on the track was not functioning properly and recommended a warning for all three individuals. The Stewards agreed and did issue a stern warning.

**RULING #17 – JACQUI NAVARRE (#21GG0092)**

**Ruling #17**

Trainer **Jacqui Navarre**, who started the horse **Code Ribbon**, who finished third in the seventh race at Golden Gate Fields on October 30, 2021, is fined Five Hundred Dollars (\$500.00)\* pursuant to Rule #1887 (Trainer or Owner to Insure Condition of Horse) for violation of Rule #1843 (a) & (d) (Medications, Drugs and Other Substances) and Rule #1843.1 (b) (Prohibited Drug Substance- Dimethylsulfoxide (DMSO) 74.8 ug/ml [Class 4] ).

Furthermore, Trainer **Jacqui Navarre** is assessed one half (1/2) point in accordance with California Horse Racing Board Rule #1843.4 (Multiple Medication Violations- Expires 01/29/23).

The above Ruling was issued after the Stewards considered the evidence and testimony presented during the hearing held on January 27, 2022.

**Ms. Navarre** was very candid during the hearing and acknowledged using DMSO on **Code Ribbons'** legs the day before she started.

**VIDEO REVIEW – JOCKEY SANTOS RIVERA**

Jockey **Santos Rivera** and the Stewards reviewed the video of the seventh race from Friday, January 28, 2022. During the stretch run **Mr. Rivera** was observed attempting to drive between two rivals with little room and was forced to steady after making contact. **Mr. Rivera** was issued a stern warning regarding his decision making, especially while out of contention and placing himself in a precarious situation.

**CLAIM VOIDED – 4<sup>TH</sup> RACE**

The claim submitted in the fourth race by Trainer **Reid France** for the three year old **Tex Hanley** was voided by the Stewards after they were notified by the Official Veterinarian **Tim Grande**, DVM, that the gelding was unsound in the left hind leg. **Tex Hanley** was returned to Trainer **Craig Dollase's** barn.

**STEWARDS REVIEW – 6<sup>TH</sup> RACE**

The Stewards conducted a video review for the benefit of the wagering public regarding the awkward start of #1 **Jays Angel** (Tr. **Daniel Franko**). The video shows the three year old ducked in sharply and Jockey **Erick Lopez** was fortunate to hang on and straighten the errant three year old filly. **Jays Angel** was eventually eased and was placed on the Stewards list.

**CLAIM VOIDED – 5<sup>TH</sup> RACE**

The claim in the fifth race for #2 **Cape Point** (Tr. **Victor Trujillo**) submitted by Trainer **Jonathan Wong** was voided by the Stewards after they were notified by the Official Veterinarian **Tim**

**Grande** that the six year old gelding was unsound in the left foreleg. **Cape Point** was returned **Mr. Trujillo's** barn.

**INQUIRY ACCIDENT – 9<sup>TH</sup> RACE**

The Stewards put up the Inquiry sign following the ninth race for a review of an incident at the start. The video clearly shows #1 **Wind In His Sail** (Tr. **Daniel Franko**) duck in sharply leaving the starting gate and unseat Jockey **William Antongeorgi III**. The Outrider quickly caught the three year old gelding who was not injured, nor was Jockey **Antongeorgi III**. **Wind In His Sail** was placed on the Stewards list.
