After a thorough review the Stewards decided unanimously to make the original order of finish official. The video shows #1 **Carolina Mia** broke out sharply leaving the starting gate and bumped #2 **Premiumonsaturday** but had no bearing on the outcome.

Mr. Fuentes' mount **Carolina Mia** (Tr. **Felix Rondan**) broke out sharply leaving the starting gate and the Stewards were concerned with his effort of controlling the five year old mare.

Mr. Fuentes stated it was not his best effort and assured the Stewards he would do better after they issued their warning for this incident.

3/13/22³**CLAIM VOIDED – 1ST RACE**

The Stewards voided the claim submitted by Trainer **Pablo DeJesus** for the four year old **Big Brand** (Tr. **Ruby Thomas**) after they were notified by the Official Veterinarian **Forrest Franklin DVM**, that the filly was lame in the right foreleg. **Big Brand** was returned to the **Ruby Thomas** barn.

The Stewards provided a review of the eighth race start for the wagering public. The video shows #1 **Wind In His Sail** (**Santos Rivera**) lifted as the stall doors opened and was off to a poor start.
