**RULING #31 BRAYAN PENA**

**Ruling #31**

Jockey **Brayan Pena** who rode **Unthrottled** in the fifth race at Golden Gate Fields on Sunday, March 27, 2022, is fined the sum of Five Hundred Dollars (\$500.00)\*; for violation of California Horse Racing Board Rule #1688 (b) (7) (Use of Riding Crop-used more than two times in succession).

The foregoing Ruling was issued after Jockey **Brayan Pena** met with the Stewards for a review of the fifth race from Sunday, March 27, 2022.

**Mr. Pena** was observed using his riding crop more than the allowed two times in succession soon after the start. **Mr. Pena** acknowledged his transgression and accepted the penalty imposed.

**VIDEO REVIEW – WILLIAM ANTONGEORGI III**

Jockey **William Antongeorgi III** and the Stewards reviewed the video of the second race from Sunday, March 27, 2022. This was not the first time the six year old mare has failed to make it to the Starting Gate on the Tapeta Main Track.

**Mr. Badilla** has requested to try **Grinningeartoear** on the Turf with the understanding that if she fails again, she will be barred from racing.

**RULING #32 – JEFFREY BONDE**

**Ruling #32**

Trainer **Jeffrey Bonde** who was scheduled to start **Come On Come On** in the eighth race at Golden Gate Fields on Saturday, April 2, 2022, is fined Three Hundred Dollars (\$300.00)\* pursuant to California Horse Racing Board Rule #1629 (Penalty for Late Declaration), for violation of California Horse Racing Board Rule #1698 (Failure to Start and Run).

The above Ruling was issued as Trainer **Jeffrey Bonde** notified the Stewards that he did not ship the three year old gelding **Come On Come On**, scheduled to run in the eighth race on Saturday, April 2, 2022. **Mr. Bonde** indicated the owners (**Great American Horse Racing**) did not want to run.

**CLAIM VOIDED – 1<sup>ST</sup> RACE**

The Stewards voided the claim submitted by Trainer **Ed Moger** for the three year old **Malibu Ghost** (Tr. **Reid France**) after being notified by the Official Veterinarian, **Forrest Franklin**, DVM, that the gelding was lame in the left foreleg and placed on the Veterinarians List. **Malibu Ghost** was returned to the **Reid France** barn.

**CLAIM VOIDED – 2<sup>ND</sup> RACE**

The claim submitted by Trainer **Blaine Wright** for the five year old **Speedy Trip** (Tr. **Jack Steiner**) was voided by the Stewards after the Official Veterinarian, **Forrest Franklin**, DVM, informed them the gelding bled out of both nostrils and was placed on the Veterinarians List. **Speedy Trip** was returned to the **Jack Steiner** barn.
