Refunds \$322.908<sup>TH</sup> Race #1 **Zuboshi** (Tr. **Steve Sherman**) Unsound – DVM **Hassan** Refunds \$494.769<sup>TH</sup> Race #7 **Daniela Bella** (Tr. **Ed Moger**) Sick – DVM **Parker** Refunds \$316.204/22/22<sup>2</sup>**CLAIM VOIDED – 7<sup>TH</sup> RACE**The Stewards voided the claim submitted by Trainer **Reid France** for **Heat N Reheat** (Tr. **Faith Taylor**) after being notified by the Official Veterinarian **Forrest Franklin**, DVM, that the five year old gelding was lame in the left foreleg and placed on the Veterinarian's List.**Heat N Reheat** was returned to the **Faith Taylor** Barn.4/22/22<sup>3</sup>**INQUIRY – DISQUALIFICATION – 8<sup>TH</sup> RACE**

The Stewards posted the Inquiry Sign following the eighth race for a review of an incident at the start involving #5 **Lovely Colleen (Kevin Orozco)** second, #4 **Iconic Sky (Assael Espinoza)** sixth and #3 **Amaaza (Silvio Amador)** who finished seventh.

After considering the Patrol Judges Report, interviewing the riders involved and reviewing the video, the Stewards decided unanimously to disqualify #5 **Lovely Colleen** from second and place her last behind both #4 **Iconic Sky** and #3 **Amaaza**.

The video clearly shows #5 **Lovely Colleen** break in sharply out of the gate, bump and impede #4 **Iconic Sky**, who in turn bumped #3 **Amaaza**, nearly dislodging Jockey **Amador**. The incident prevented the latter two fillies the opportunity of a better placings.

**VIDEO REVIEW**

Jockey **Kevin Orozco** met with the Stewards for a review of the eighth race from Friday, April 23, 2022. **Mr. Orozco's** mount **Lovely Colleen** was disqualified from second to seventh (last) for interference at the start.

After a thorough review the Stewards decided unanimously that the three year old filly broke in the first step and **Mr. Orozco** made an effort to correct her as quickly as he could, and no penalty is warranted.

The Stewards voided the claim for #4 **Union Boy** (Tr. **Tim Bellasis**) submitted by Trainer **Mike Lenzini** after the Official Veterinarian **Forrest Franklin** DVM reported the four year old gelding bled and was placed on the Veterinarians list. **Union Boy** was returned to the **Bellasis** barn.

**RULING #45 – EVIN ROMAN**

**Ruling #45**

Jockey **Evin Roman** who rode **Autism Innocence** in the eighth race at Golden Gate Fields on Saturday, April 23, 2022, is fined Seven Hundred – Fifty Dollars (\$750.00)\* for violation of California Horse Racing Board Rule #1688 (Excessive Use of Riding Crop).

Jockey **Evin Roman** met with the Stewards regarding his use of the riding crop during the eighth race on Saturday, April 23, 2022.

**Mr. Roman** was observed using his crop approximately eleven times during the running of the race. The veteran rider was very apologetic and accepted the penalty imposed.

**JOCKEY FRANCISCO DURAN**

Jockey **Francisco Duran** met with the Stewards regarding his failure to fulfill his riding engagement on **Impressive Curls** in the ninth race on Saturday, April 24, 2022.

**Mr. Duran** explained that he does not have an agent and when he checked the overnight for Saturday, he had no mounts for that day. Prior to the program going to print Trainer **Clifford DeLima** changed the rider on **Impressive Curls** from **Francisco Monroy** to **Francisco Duran**. The Stewards decided that no penalty was warranted for **Mr. Duran**.

**CLEAR AFTERNOON**

With the exception of Jockey **Silvio Amador** being unseated from his mount **You Kidding Me** (Tr. **Tim Bellasis**) while pulling up following the ninth race, the racing program was conducted without any other noteworthy incidents.
