WEDNESDAY3/23/22¹**ENTRY PANEL / ENTRIES**

The full Board of Stewards, **Baker**, **Lewis** and **Nevin**, were present to hear California Horse Racing Board Complaint #22GG0018, **CHRB v Allison**. After Hearing testimony and viewing evidence the proceedings were closed. A decision will follow after deliberations.

3/25/22²**FILM REVIEW**

Jockeys **Armando Ayuso** and **Evin Roman** viewed replays of Sunday's seventh race which involved a "Stewards Inquiry". Actions passing the half mile marker by the above mentioned riders were questioned when Jockey **Irving Orozco** had to steady along the rail. Stewards **Nevin** and **Lewis** felt **Ayuso** and **Roman** each were somewhat responsible but not suspension worthy. Steward **Baker** dissented voicing days for **Ayuso**.

COUTON FILM REVIEW

Jockey **Julian Couton** met with this Panel to review the start of the sixth race on Sunday. His mount #8 "**Trash Talkin Cat**" broke in sharply. Fortunately, #7 broke slow and was not impeded. **Mr. Couton**, when questioned, admitted that he should have reacted quicker in grabbing with his right hand. The Stewards agreed and issued a verbal advisement to make every effort to maintain a straight course when leaving the starting barrier.

ALLISON RULING #30

Ruling #30

Veterinarian **Kenneth C. Allison** is fined the sum of Two Hundred Dollars (\$200.00)* for violation of California Horse Racing Board Rule #1864 (Labeling of Medications).

The prior Ruling was issued after this Board of Stewards discussed the issues involved in California Horse Racing Board Rule Complaint #22GG0018 (Ref 3/24/22²).

RACE 2 VOIDED CLAIM

California Horse Racing Board Veterinarian **Forrest Franklin** observed "**Austrian Navy**" to be unsound, left front leg, while being cooled out in the test barn. Upon receiving this information this panel voided the claim submitted for the four year old filly and ordered her to remain in the care of Trainer **Monty Meier**.

RACE 3 LATE SCRATCH

The seven horse "**Funky Grey**" was declared by the Board of Stewards after being advised by **Dr. Batten** that the 4 year old filly flipped in the paddock. This action also brought the number of Starters to six which caused the Rolling Super High Five to be cancelled.

RACE 1 – VOIDED CLAIM

The claim of #3 **Morphy** was voided by the Stewards after California Horse Racing Board Veterinarian **Franklin** added the three year old to the "Vet's List". Soundness issues in the left hind contributed to this action. Horse will stay in the care of Trainer **Reid France**.

RACE 3 – DEAD HEAT

As the horses crossed the wire the Stewards requested a photo for show between #4, **Blue Silver** and #7 **Western Sierra**. The picture provided could not clearly define which runner hit the line first. The Stewards, after discussion with Placing Judges, were unanimous in calling a Dead Heat. The official order of finish for the third race is: 5 – 3 – 8 – **4/7** – 2 – 6 – 1

3/26/22⁴

RACE 3 - VOIDED CLAIM

California Horse Racing Board Veterinarian **Franklin** reported to the Stewards that #5, **Word Of Warning**, was put on the Vet's List as unsound with lameness associated to the right hock. Upon receiving that information, the Stewards voided the claim. Horse will remain in the barn of **Jonathan Wong**.

3/26/22⁵

RACE 4 – VOIDED CLAIM

While performing his claim examination California Horse Racing Board Veterinarian **Franklin** observed #1 **Gee Gee Whiz** being off in his left foreleg. The five year old was added to the Vet's List, resulting in the Stewards voiding the claim. Trainer **Jonathan Wong** was ordered to maintain control of **Gee Gee Whiz**.

3/26/22⁶

RACE 8 – STEWARDS' REVIEW

The Stewards showed a review of the start of this five furlong turf dash to the public. The post time favorite #3 **Trina** bobbled at the start, losing contact with the field. After showing multiple shots of different angles, it was evident the six year old mare's problems were self-inflicted. The Stewards were unanimous, and the race went official.

RACE 2 – INQUIRY – DISQUALIFICATION

Stewards had the Inquiry illuminated after the horses crossed the wire to look into a bumping incident inside the 3/16ths pole. Racing head to head on the lead. #1 **Leigh Ann** with Jockey **William Antongeorgi III**, bumped #5 **Maydaysmoon**, ridden by Apprentice **Adrian Martinez**. #5 was forced off her path and began to lose ground finishing fourth. After reviewing video and talking to riders and Patrol Judge, the Stewards were in agreement that **Maydaysmoon** was cost a better placing. #1 **Leigh Ann** was disqualified from second and placed fourth which moved #5 into show position.
