Report for the Week of Thursday, June 2, 2022, through Sunday, June 5, 2022.**THURSDAY**6/2/22¹**DUTY STEWARD**Steward **Will Meyers** was present to oversee entries for Sunday June 5, 2022.**FRIDAY**6/3/22¹**DECLARATIONS:**4TH Race: #2 **After Sundown** (Tr. **Clifford DeLima**) Sick – DVM **Hassan** Refunds \$144.886TH Race: #3 **Premium Forest** (Tr. **Blaine Wright**) Unsound – DVM **Parker** Refunds \$267.198TH Race: #1 **Bold Mistress** (Tr. **Ed Moger**) Unsound – DVM **Hassan** Refunds \$134.366/3/22²**RULING #65 – DRADEN VAN DYKE****Ruling #65**Jockey **Drayden Van Dyke** is fined Fifty Dollars (\$50.00)* for violation of California Horse Racing Board Rule #1680 (Jockeys and Drivers to Report) on May 30, 2022, at Golden Gate Fields.The foregoing Ruling was issued as Jockey **Van Dyke** waived his right to a hearing, acknowledged he reported late to the Jockeys room prior to the first race on Monday, May 30, 2022. **Mr. Van Dyke** apologized and indicated he forgot to request permission to be late.6/3/22³**JOCKEY VIDEO REVIEW – JOSE RODRIGUEZ**Apprentice Jockey **Jose Rodriguez** and the Stewards reviewed his ride on #6 **Fromajacktoaking**, who finished last in the fifth race on Monday, May 30, 2022.

The young riders mount was observed bumping #4 **Magicisthemoonlight**, (**Cristobal Herrera**) near the ½ mile pole during this one mile turf event.

After a thorough review the Stewards determined unanimously that the five year old gelding took a bad step after changing leads which initiated the contact and absolved the young rider.

CLAIM VOIDED – 1ST RACE

The claim submitted by Trainer **D.W. Baker** for the four year old **Rich Warrior** (Tr. **Reid France**) in the race was voided by the Stewards after they were notified by the Official Veterinarian **Forrest Franklin, DVM** that the gelding was unsound in the right foreleg and placed on the Veterinarians List. **Rich Warrior** was returned to the **Reid France** Barn.

INQUIRY – OBJECTION – DISQUALIFICATION – 3RD RACE

The Stewards posted the Inquiry sign following the third race for a review of an incident inside the 1/16 pole involving #3 **Dizzy Dazmura** (**Catalino Martinez**) second and #1 **Daddy'sfavorite son** (**Daniel Vergara**) who finished fifth. Jockey **Vergara** also lodged a claim of foul regarding the same incident.

After considering the patrol judges report, interviewing the riders involved and reviewing the video, the Stewards decided unanimously to disqualify #3 **Dizzy Dazmura** from second to fifth. The video shows #3 **Dizzy Dazmura** drift into the path of #1 **Daddy'sfavoriteson** forcing latter to check sharply and lose the opportunity of a better placing.

RULING #66 – CATALINO MARTINEZ

Ruling #66

Jockey **Catalino Martinez** who rode **Dizzy Dazmura** in the third race at Golden Gate Fields on Friday, June 3, 2022, is suspended three (3) racing days June 11, 12 & 17, 2022 for failure to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fifth; a violation of California Horse Racing Board Rule #1699 (Riding Rules-Careless Riding).

The above Ruling was issued after **Mr. Martinez** and the Stewards reviewed the video of the third race from June 3, 2022. The veteran rider acknowledged his mount drifted off his path, causing the interference and accepted the penalty imposed.
