Safety Steward **George Yniguez** handled panel duties for Saturday's card.9/1/22²**TERRI EATON HEARING CASE 22GG0048**Trainer **Terri Eaton** was issued a warning for failing to have a pre-work examination performed on her horse "**One Last Thought**" who worked on April 8, 2022. **Ms. Eaton** has no prior violations of Rule #1878.9/1/22³**DELIMA HEARING CASE 22GG0057, 22GG0078, 22GG0080**A hearing was held for Trainer **Clifford DeLima** who was cited for failing to have numerous horses vet checked prior to workouts. The dates of the alleged violations were 4/9/22, 4/10/22, & 4/16/22. **Mr. DeLima** plead guilty stating that at his age (91 years) he gets forgetful. The following Ruling was issued:

Amended Ruling #2

Trainer **Clifford DeLima** is fined Five Hundred Dollars (\$500.00)* for multiple violations of California Horse Racing Board Rule #1878 (b) (2) (Workouts. Pre-work examination required within 72 hours of workout).

RONDAN HEARING CASES 22GG0044, 22GG0046, 22GG0055, 22GG0063, 22GG0073

A Hearing was held for Trainer **Felix Rondan** who was cited for failing to have numerous horses vet checked prior to working. The dates of the alleged violations were 4/1/22, 4/7/22, 4/8/22, 4/9/22 & 4/10/22. Investigator **Jerry Smith** presented the case and Investigator **Noe Longoria** helped translate anything **Mr. Rondan** didn't understand. During the hearing **Mr. Rondan** requested his Veterinarian **Jerry Parker** testify. **Dr. Parker** was not available, so the case was continued until tomorrow.

RONDAN (CONTINUED) REF 9/1/22⁴

Mr. Rondan appeared today, and his Veterinarian **Dr. Jerry Parker** was present to testify. **Dr. Parker** testified that he had checked one of the horses on the list and that he did not check four other horses on the list because he was told by State Veterinarian **Forrest Franklin** that two furlong workers didn't need an exam. **Dr. Franklin** was not present to dispute that comment. There were still some that **Mr. Rondan** or **Dr. Parker** could not explain so the following Ruling was issued:

Ruling #3

Owner/Trainer **Felix D. Rondan** is fined Three Hundred Dollars (\$300.00)* for multiple violations of California Horse Racing Board Rule #1878 (b) (Workouts-Pre work examination required within 72 hours of workout).

REID FRANCE HEARING CASE 22GG0058, 22GG0081

A hearing was held today for Trainer **Reid France** who was cited with numerous violations of failing to have his horses vet checked within 72 hours of workouts. Trainer **France** testified that he makes a list on Sunday of horse that are going to work or race and gives a copy to his Veterinarian. His Veterinarian then does the examinations "when he has time". Unfortunately, the exams end up outside the 72 hour rule parameter mostly 96 hours out. **Mr. France** understood the violation and accepted the following Ruling:

Ruling #4

Owner/Trainer **Reid France** is fined Three Hundred Dollars (\$300.00)* for multiple violations of California Horse Racing Board Rule #1878 (b) (Workouts-Pre work examination required within 72 hours of workout).

EPIFANIO GARCIA RULING

Ruling #5

Jockey **Epifanio Garcia** who rode **Approval Given** in the first race at Humboldt County Fair on Sunday, August 28, 2022, is fined the sum of Seven Hundred and Fifty Dollars (\$750.00) for violation of California Horse Racing Board Rule #1688 (Use of Riding Crop-used more than six times, second offense).

Jockey **Garcia** appeared and accepted responsibility for his second crop violation on the same Quarter Horse within 60 days.

ROGER HANSEN HEARING CASE 22GG0066

Trainer **Roger Hansen** was issued a warning for failing to have a pre-work examination performed on his horse "**Cardinal Trick**" who worked on April 10, 2022. **Mr. Hansen** has no prior violations of Rule #1878.

CLAIM VOIDED 4TH RACE

The claim submitted by **Reid France** for the ridgling "**Mashhad Flats**" was deemed void after State Veterinarian **Forrest Franklin** reported him sore in both front legs. "**Mashhad Flats**" was returned to Trainer **Isidro Tamayo**.

ACCIDENT/INQUIRY – NO CHANGE

The inquiry sign was posted to determine the reason #2 **Jazz City** unseated Jockey **William Antongeorgi III** at the start. After a thorough review it was obvious that #2 "Wheeled" at the start causing Jockey **Antongeorgi** to lose his balance and fall. No other horses were involved and #2 was declared a Starter, no change.

BRENDAN GALVIN HEARING CASE 22BM0035

Trainer **Brendan Galvin** was cited for 4ng/ml of Methocarbamol in the test sample from the horse "**Sound Of The Surf**". The limit on Methocarbamol is 1ng/ml. State Veterinarian **Forrest Franklin** felt that since the horse was administered Methocarbamol in the days prior to the race by **Mr. Galvin** crushing pills and dissolving in water and an IV shot given by **Dr. Kuhlmann** 53 hours prior to the race most likely caused the overage. **Mr. Galvin** has a spotless medication history, so the minimum penalty was issued in the following Ruling.

Ruling #6

Owner/Trainer **Brendan W. Galvin** who started the horse "**Sound Of The Surf**" who finished first in the fifth race at Alameda County Fair on Saturday, July 9, 2022 is fined Five Hundred Dollars (\$500.00) pursuant to California Horse Racing Board Rule #1887 (a) (Trainer or Owner to Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843 (a) (b) & (d) (Medications, Drugs and Other Substances) & #1843.1 (b) (Methocarbamol-in excess of permitted level, 4ng/ml [Class 3]) (Penalty - Class C).

EVIN ROMAN RULING

Ruling #7

Jockey **Evin Roman** who rode **Early Release** in the seventh race at Golden Gate Fields on Sunday, September 4, 2022, is suspended one (1) racing day, Friday, September 16, 2022, and fined Two Hundred and Fifty Dollars (\$250.00)* for one (1) strike over the limit pursuant to Horseracing Integrity and Safety Authority (HISA) Rule #2282 (Riding Crop Violations and Penalties – Class 3) for violation of HISA Rule #2280 (Use of Riding Crop).

Furthermore, Jockey **Evin Roman** is assigned three (3) violation points that will expire on March 5, 2023, six months from the date of final adjudication pursuant to HISA Rule #2280 (Riding Crop Violations and Penalties).

The above Ruling was issued after **Mr. Roman** appeared and reviewed the race in question. He sheepishly admitted that he struck his mount 7 times.

JOSE RODRIGUEZ RULING

Ruling #8

Jockey **Jose Rodriguez** who rode **Honos Man** in the ninth race at Humboldt County Fair on Sunday, August 28, 2022, is suspended one (1) racing day, Friday Sept 16, 2022, and fined Two Hundred and Fifty Dollars (\$250.00)* for two (2) strikes over the limit pursuant to Horseracing Integrity and Safety Authority (HISA) Rule #2282 (Riding Crop Violations and Penalties – Class 3) for violation of HISA Rule #2280 (Use of Riding Crop).

Furthermore, Jockey **Jose Rodriguez** is assigned three (3) violation points that will expire on March 5, 2023, six months from the date of final adjudication pursuant to HISA Rule #2280 (Riding Crop Violations and Penalties).

The above ruling was issued after the T.V. Department furnished us the disc with Ferndale's last day of racing. **Rodriguez** was shown the race and agreed he made an error.
