1/20/23¹**SILVIO AMADOR RULING****Ruling #13**

Jockey **SILVIO AMADOR** who rode **EMERALD MAGIC** in the first race at **GOLDEN GATE FIELDS** on Monday, January 16, 2023, is suspended one (1) racing day, Friday January 27, 2023, and fined Two Hundred and Fifty Dollars (\$250.00)* pursuant to Horseracing Integrity and Safety Authority (HISA) Rule #2282 (Riding Crop Violations and Penalties – Class 3, one strike over the legal limit) for violation of HISA Rule #2280 (Use of Riding Crop).

Furthermore, Jockey **SILVIO AMADOR** is assigned three (3) violation points that will expire on July 20, 2023, six months from the date of final adjudication pursuant to HISA Rule #2282 (Riding Crop Violations and Penalties). Jockey **SILVIO AMADOR** has now accumulated nine (9) points.

Ruling #7 Pacific Racing Association – January 7, 2023

Ruling #8 Pacific Racing Association – January 7, 2023

The above ruling was issued after **Mr. Amador** appeared and reviewed the race in question. He agreed that he struck his mount seven times in the race, one over the limit. **Mr. Amador** has now accumulated nine points in a short period of time. He was cautioned that the next mistake could cost him seven days of racing.

Replays show #8 pointed toward a hole between #6 on the inside and #5 **Granola Girl (Assael Espinoza)** on the outside. #8 is checked by Jockey **Couton** as the hole tightens but never closes. #8 was never close enough to the other two rivals to be affected.

COUTON RULING

Ruling #14

Jockey **JULIEN COUTON**, who rode **RELUCTANT** in the first race at Golden Gate Fields on January 21, 2023, is suspended one (1) racing day, January 29, 2023, and fined Two Hundred Fifty Dollars (\$250.00)* pursuant to Horseracing Integrity and Safety Authority (HISA) Rule #2282 (Riding Crop Violations and Penalties – Class 3, one strike over the legal limit) for violation of HISA Rule #2280 (Use of Riding Crop).

Furthermore, Jockey **JULIEN COUTON** is assigned three (3) violation points that will expire on July 22, 2023, six months from the date of final adjudication pursuant to HISA Rule #2282 (Riding Crop Violations and Penalties). Jockey **JULIEN COUTON** has now accumulated three (3) points.

The above ruling was issued after Jockey **Couton** appeared and reviewed the race with the Stewards. He realized that he miscounted in the heat of battle while vying for the win.
