THURSDAY4/30/26¹**TRAINER RODOLFO VIRAMONTES – COMPLAINT (Case #26LA0041)**

An informal tape-recorded hearing was conducted this morning to address California Horse Racing Board (complaint #26LA0041) filed against trainer Rodolfo Viramontes. The complaint was submitted by Official veterinarian Jocelyn Lorbiecki, alleging violation of CHRB rule #1846.2 (Training Soundness Exams).

Present, in addition to the Board of Stewards, were Mr. Viramontes and CHRB Supervising Investigator Kevin Kitashima, who presented the case.

Mr. Viramontes was advised of his right to counsel and elected to proceed without representation. He subsequently testified on his own behalf. Upon conclusion of Mr. Viramontes testimony, the hearing was adjourned. The Stewards will review the testimony and exhibits submitted and will render a decision in due course.
