**Report for the Week of Wednesday, September 23, 2020 through Sunday, September 27, 2020**

**WEDNESDAY**9/23/20<sup>1</sup>**ENTRY DAY**

Steward **Dennis Nevin** was on duty today overseeing entries for Saturday, September 26, 2020. Racing Secretary **Patrick Mackey** and his staff put together an 'Overnight' of ten (10) races for the weekend card. Seventy-five (75) horses are scheduled to start.

**THURSDAY**9/24/20<sup>1</sup>**NEW VETERINARIAN**

The **Stronach Group** (TSG) Veterinarian **Casille Batten** visited the Stewards Office to introduce us to a new colleague. **Dr. Emily Putt** will now serve as a morning examining veterinarian. **Dr. Putt** is currently replacing former horse trainer and current veterinarian **Dr. Mark Christin** who is off for the time being.

9/24/20<sup>2</sup>**BRAYAN PENA FILM REVIEW (REF 9/20/20<sup>8</sup>)**

Jockey **Brayan Pena** appeared in the Stewards' office to review his winning ride aboard the **Gloria Haley** trained #9 '**Oasis**' in the tenth race on Sunday, September 20, 2020. The Stewards conducted an Inquiry into the actions of #9 **Oasis** in the final one-sixteenth of this one (1) mile turf event. Today's review shows Jockey **Pena** employing his riding crop (left-handed) while his mount is continually drifting out approaching the finish line. This action forced fourth place finisher #4 **KPD Day (Santos Rivera)** to steady his horse off the heels of the eventual winner #9 **Oasis**. The Stewards unanimously felt Jockey **Pena's** actions were careless. **Mr. Pena** who survived a Stewards' Inquiry on this day in a 2-1 vote, did not disagree. The following ruling was issued.

**Ruling # 43**

Jockey **Brayan Pena** who rode **Oasis** in the 10<sup>TH</sup> race at Golden Gate Fields on Sunday, September 20, 2020 is suspended Three (3) racing days October 1, 2 & 3, 2020 for failure to maintain a straight course in the stretch causing interference. A violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

**ALEJANDRO GOMEZ FORMAL HEARING (REF: 08/20/20<sup>7</sup>)**

Jockey **Alejandro Gomez** appeared in our office today for a recorded hearing. He was accompanied by his agent **Ramon Silva** who assisted with English to Spanish translation. Along with the Stewards, also present was Court Reporter **Christine Niccoli (Niccoli Reporting)**. Steward **Will Meyers** chaired the hearing.

The purpose of today's hearing was to review Jockey **Gomez'** ride aboard #4 **Shot Of A Lifetime** who did not finish the one and one-half (1 ½) mile turf event. Compliance with California Horse Racing Board Rule #1692 (Requirements for Horse, Trainer and Jockey) was of primary concern to the Stewards. The Stewards reviewed a DVD replay of this race with Jockey **Gomez** who stood up in the saddle and eased his horse to the outside crossing the finish line the first time. There still was still about seven (7) furlongs left to race. The following items were noted on the record.

1. This was the eighth time that Jockey **Gomez** has ridden **Shot Of A Lifetime** for Trainer **Ellen Jackson**.
2. Jockey **Gomez** has never ridden this horse in a race at less than one (1) mile.
3. There is a Daily Racing Form in the jockey's room available for jockeys to review before their particular race.
4. Jockey **Gomez** did not review the Daily Racing Form before the eighth race.
5. Jockey **Gomez** did **not** bet on this race.
6. Jockey **Gomez** was profoundly sorry for his actions. He apologized to horse bettors, the owner/trainer of his mount and the Stewards alike. He told us that he thought this race was a five (5) furlong sprint race as he is not used to the one and one half (1 ½) mile turf gate placement. The Stewards will now deliberate over today's testimony and evidence (Official Program & Race 8 DVD) presented. Decision to Follow.

**HILAY MARTINEZ RULING**

Jockey **Alejandro Gomez** appeared in the Stewards Office this morning at our request. He was accompanied by his agent **Ramon Silva**. Jockey **Gomez** pulled up #4 **Shot Of A Lifetime** the first time passing the finish line in a race in which he had a full lap to go in a race that was programmed at 1 ½ miles on the turf. In a unanimous decision the following ruling was issued.

**Ruling # 45**

Jockey **Alejandro Gomez** who rode 'Shot Of A Lifetime' in the eighth race on Sunday, September 20, 2020 is hereby suspended for fifteen (15) days October 2, 2020 through and including October 16, 2020 for violation of California Horse Racing Board rule #1692 (Requirements for Horse, Trainer and Jockey-failure to ride his mount out until the finish line is passed).

#### **BRAYAN PENA COMPLAINT (CASE #20GG073)**

Jockey **Brayan Pena** appeared in our office this morning to answer to charges stemming from a positive urine test for **Marijuana** on August 7, 2020 at Golden Gate Fields. On August 15, 2020, a Quest Diagnostic Laboratory report split sample analysis report a 'Positive'. California Horse Racing Board Investigator **Jerome Smith** presented this case for the California Horse Racing Board. Jockey **Pena** acknowledged that he used **Marijuana** prior to August 7, 2020. The positive test was a result of 'Random Drug Testing' that was conducted by the California Horse Racing Board. Decision to follow.

#### **ANOTHER BRAYAN PENA COMPLAINT (CASE #GG0076)**

The second hearing stemmed from an additional urine sample (requested by Jockey **Bryan Pena**) that was taken the day after Jockey **Pena** tested positive for **Marijuana**. Jockey **Pena** wanted to get back riding as soon as possible and did not ride for approximately seven (7) for days total until he submitted a clean test. Decision to Follow.

**BRAYAN PENA RULING #49 (REF 9/26/20<sup>1</sup>)**

The Stewards deliberated following two (2) hearings that were conducted for Jockey **Pena** yesterday September 26, 2020. The first hearing was held after Jockey **Pena** tested positive for Marijuana when California Horse Racing Board enforcement conducted 'Random Drug Testing' involving a group of jockeys on August 7, 2020. This matter was labeled Case #20GG0073. Before issuing the following ruling the Stewards spoke with **Darrin Scherrer** from the Winners' Foundation, which assists California Horse Racing Board licensees with drug and alcohol issues, anger management etc. Mr. **Pena** must meet with **Mr. Scherrer** in order to conform with the following ruling that was issued in a unanimous vote.

**Ruling #49**

Jockey **Brayan Pena** is hereby fined the sum of Two Hundred Dollars (\$200.00)\* pursuant to #1500.1 (Random Drug Testing) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct- Positive Marijuana Test).

Further **Brayan Pena** must be evaluated by the Winners Foundation and placed on a Testing Agreement with the California Horse Racing Board.

The Stewards' unanimously voted to dismiss Case #GG0076 as this complaint resulted from a second urine test that Jockey **Pena** requested on August 8, 2020 the day after he originally tested positive. Our decision was unanimous.

### LILY AI RULING

Exercise Rider **Lily Ai** appeared in the Stewards Office this morning at the behest of Golden Gate Fields Morning Outriders. She was accompanied by Trainer **Victor Trujillo**. Following what **Ms. Ai** claims was a two (2) furlong workout her mount remained galloping on the 'inside rail'. A pair of workers then traveled inside and outside of **Ms. Ais'** horse while they were conducting an official workout. This created safety concerns as all horses are to be taken to the middle of the racetrack following a workout. The Stewards in a unanimous decision issued the following ruling.

#### Ruling # 50

Exercise Rider **Lily Ai** is fined the sum of One Hundred Dollars (\$100.00)\* for unsafe riding on the main track during morning training hours on September 27, 2020; a violation of California Horse Racing Board rule #1530 (Cases Not Covered).
