Jockey **Francisco Monroy** who rode '**Al Million Bob**' in the first race at Golden Gate Fields on May 31, 2021, is suspended three (3) racing days June 11, 12 & 13, 2021 for violation of California Horse Racing Board Rule #1688 (Use of Riding Crop-used more than six (6) times during a race).

The foregoing ruling was issued by unanimous decision after **Mr. Monroy** and the Stewards reviewed the video of the first race from May 31, 2021.

Mr. Monroy was very forthright by acknowledging he used his riding crop more than the allowable six times during the race.

TRAINER ANDY MATHIS (21GG0043) (REFER 5-13-21²)

Trainer **Andy Mathis** was issued a warning by unanimous decision following a tape recorded hearing held on May 31, 2021.

INQUIRY – DISQUALIFICATION – 3RD RACE

The Stewards posted the Inquiry sign following the third race for a review of an incident soon after the start involving #6 **Drasario (IRE) (Evin Roman)** first and #4 **Preacher Brown (Alejandro Gomez)** who finished sixth. After considering the patrol judges report, interviewing the riders involved and reviewing the video of the race, the Stewards decided by a majority decision (**Baker** Dissenting) to disqualify #6 **Drasario (IRE)** from first to sixth.

The video shows #6 **Drasario (IRE)** cross over into the path of #4 **Preacher Brown**, without sufficient clearance, forcing his rider to take back sharply to avoid clipping heels, lose ground and the opportunity of a better placing.

CLAIM VOIDED – 4TH RACE

The Stewards voided the claim submitted by Trainer **D.W. Baker** for #1 **Hot Socks** (Tr. **Jonathan Wong**) the winner of the fourth race after being notified by the Official Veterinarian **Kathy Jones, DVM** that the four year old gelding was unsound in the right foreleg and placed on the Veterinarians' list. **Hot Socks** was returned to **Mr. Wong's** barn.

RULING #82 – BRAYAN PENA

Ruling #82

Jockey **Brayan Pena** who rode "**Only The Facts**" in the first race at Golden Gate Fields on June 4, 2021, is suspended three (3) racing days, June 12, 13 & 18, 2021 for altering course without sufficient clearance causing interference in the stretch; a violation of California Horse Racing Board Rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The above ruling was issued by unanimous decision after **Mr. Pena** and the Stewards reviewed the video of the first race from Friday June 4, 2021. **Mr. Pena** was very candid by acknowledging he should not have used the riding crop, left handed as his mount was drifting out, causing the interference.

RULING #83 – EVIN ROMAN (REFER 6-4-21⁴)

Ruling #83

Jockey **Evin Roman** who rode “**Drasario (IRE)**” in the third race at Golden Gate Fields on June 4, 2021, is suspended three (3) racing days, June 12, 13, & 18, 2021 for altering course without sufficient clearance shortly after the start and causing interference resulting in the disqualification of his mount from first to sixth; a violation of California Horse Racing Board Rule #1699 (c) & (e) (Riding Rules-Careless Riding).

After **Mr. Roman** and the Stewards reviewed the third race from Friday, June 4, 2021, the Stewards decided unanimously to issue the foregoing ruling. **Mr. Roman** stated he believed at the time he was clear when he crossed over into a path of a rival but can see how he was not. The veteran rider accepted the penalty imposed.

ACCIDENT - DELAY - 5TH RACE

Jockey **Alejandro Gomez** was injured when his mount, **Joymaker**, (Tr. **Quinn Howey**) reared and unseated him as the field was being loaded into the starting gate for the fifth race. As the ambulance staff and Track Physician **David Seftel, M.D.**, attended to the veteran rider, the three year old filly, **Joymaker**, returned to the paddock for a replacement rider. The initial report on **Mr. Gomez** was a dislocated left shoulder. To add insult to injury **Joymaker** went on to win the one mile and one sixteenth turf event with **Kevin Orozco** in the saddle.
