HORSE DOWN – 2ND RACE

During the running of the second race, #2 **Queen Helene** was being eased near the ¼ pole and Jockey **William Antongeorgi** was able to pull up the five year old mare at the 3/16 pole and dismount.

Queen Helene then collapsed and lay motionless until the Track Veterinarian **Casille Batten, DVM**, arrived. **Dr. Batten** reported that **Queen Helene** bled and after being washed down, cooled off and was treated with steroids, regained her footing, was given a ride back to Trainer **Jack Steiner's** barn. The last report was **Queen Helene** was doing fine.

STEWARDS REVIEW 5TH RACE

A Stewards Review was conducted to review an incident in the stretch near the 1/8 marker involving #5 **Whoa Nessie** (Jockey **Armando Ayuso** – 1ST place) and #1 **Going To Shabooms** (Jockey **Irving Orozco** – 4TH place). The recordings show #5 while going to the lead cross over and cause the rider of #1 to take up momentarily. After reviewing all the recorded views, it was readily apparent no placings were affected and the race was declared official.

EIGHTH RACE NO PHOTO FINISH

Following the running of the eighth race the Stewards were informed that both photo finish cameras failed to produce a photo strip. Luckily, all the margins were clearly discernable on the recorded views of the race, so the placings were easy. The public was informed that the place photo shown on the monitor was a still shot from the video of the race before the race was declared official. After reviewing the photo finish process and the photo finish equipment it was reported the incident was most likely caused by human error. The ninth race photo finished progressed without incident.
