**THURSDAY**9/9/21<sup>1</sup>**ENTRIES FOR SUNDAY**

Steward **Will Meyers** was present to supervise Sunday entries. Sixty-six runners filled the nine races drawn.

9/10/21<sup>2</sup>**TAMAYO RULING #6****Ruling #6**

Trainer **Isidro Tamayo** who worked the horse **Autism Ability** at Golden Gate Fields on Saturday, August 21, 2021, is fined the sum of Seven Hundred and Fifty Dollars (\$750.00)\* for violation of California Horse Racing Board Rule #1866 (b) (1) (Veterinarian List – may not work a horse for 72 hours after being placed on list – sick).

The above Ruling was issued after Trainer **Isidro Tamayo** contacted the Stewards by telephone to discuss the issues surrounding the scratch of **Autism Ability** at the Humboldt County Fair and the subsequent work at Golden Gate Fields.

9/10/21<sup>3</sup>**VOIDED CLAIM 3<sup>RD</sup> RACE**

The claim of #1 **Drasario (Ire)**, by Trainer **Marcellino Trujillo**, was voided by the Board of Stewards after **Dr. Franklin** reported the four year old as unsound in both forelegs. The gelding will remain in the care of Trainer **Jonathan Wong**.

9/10/21<sup>4</sup>

**RACE 4 EASED/BLD**

#3 **C'mon Jenna** (Tr. **M. Ramirez**) was pulled up and dismounted at the 3/16<sup>th</sup> pole. "On Track" Veterinarian **Casille Batten** reported the three year old had bled externally. Horse was vanned back to trainer's barn.

**FILM REVIEW**

Jockey **William Antongeorgi III** was present before this panel to view video of the previous day's last event. The start of the race was the point of interest. His mount, #5 **Roaring Tiger**, broke outward but video showed the rider putting forth maximum effort to control horse. No action was taken by the Stewards.

9/11/21<sup>3</sup>

**FIFTH RACE PADDOCK SCRATCH**

After being saddled #5 **Sonora Sermon** (Tr. **I. Tamayo**) fell over backwards. Veterinarian **Casille Batten**, on the scene, recommended the horse be withdrawn. The Stewards confirmed the scratch, and the horse was removed from all wagering prior to remaining horses exiting the paddock.

9/11/21<sup>4</sup>

**SEVENTH RACE LATE SCRATCH**

As horses were warming up for the 9<sup>th</sup> race Veterinarian **Casille Batten** recommended that the Stewards scratch #1 **Dangerous Illusion** (Tr. **F. Rondan**) for soundness issues. The Stewards accepted her recommendation and scratched the two year old.

**PENA FILM REVIEW – 4<sup>TH</sup> RACE**

Jockey **Brayan Pena** viewed video of the 4<sup>TH</sup> race from Friday's program. Film angles show Jockey **Pena** allowing his mount to drift outward the final 1/8<sup>th</sup>. Although his lack of keeping a

straight course did not hinder others, he was given a loud warning to be aware of his surroundings.

9/12/21<sup>3</sup>

**RODRIGUEZ FILM REVIEW – 5<sup>TH</sup> RACE**

Jockey **Jose Rodriguez** appeared to review his performance on “**Eddiespaghetti**” down the backside of this five furlong dash. The horse appeared to be injured with the rider pulling on horse. Within a 1/16<sup>th</sup> of a mile jockey started riding again and finishing race in the “show” placing. Rider then pulled horse up soon after the finish and dismounting near 7/8<sup>th</sup> pole. Horse walked off the track.

**Rodriguez** said, through an interpreter, he thought the horse was injured. When asked why he went back to riding he was unable to give a good reason. We tried to get him to understand that if he feels a horse is not 100% there is no penalty for pulling up as a precaution.

**DR. BATTEN VISIT**

**Casille Batten** the “On-Track” veterinarian stopped in to watch replays of two races. She was interested in the actions of two horses. Video showed her that one horse was getting out around the turn avoiding heels. This helped to explain the actions she saw while watching the race. The other race involved the previous entry with **Rodriguez film review**.

**MONROY RULING**

Jockey **Francisco Monroy** is hereby fined Fifty Dollars (\$50.00)\* for failure to be present in the paddock at the appointed time for the fourth race at Golden Gate Fields on Saturday, September 11, 2021; a violation of California Horse Racing Board Rule #1530 (Cases Not Covered by Rules and Regulations).

The above Ruling was published after Jockey **Francisco Monroy** contacted the Stewards by phone and accepted the penalty for his tardiness to the paddock.

**RACE 8 – INQUIRY/DISQUALIFICATION**

The Stewards had the Inquiry sign lit after watching the stretch run immediately after the finish. Consulting with both riders and viewing all angles we determined that #4 **Party Spirit (GB)** ridden by **Brayan Pena** drifted out at least four paths down the lane floating #6 **Silk Road Sally** off her path the length of the stretch. The decision to disqualify #4 from first and placing her behind #6 was unanimous.

**RACE 8 – CLAIM VOIDED**

The Stewards voided the claim of #6 **Silk Road Sally** after Veterinarian **Franklin** notified us that he had put the three year old on the Vet’s List as unsound in the hind end. The Stewards ordered the three year old to remain in the care of Trainer **Felix Rondan**.
