Proceedings of the Board of Stewards for the period of Monday, August 16, 2010 through Sunday, August 22, 2010. Steward Brent McLaren was the Reporting and Duty Steward for the enclosed period.

08/16/10 (1) **Entries**

There was a double draw for Friday and Saturday with two hundred twenty seven (227) entries. Friday had one hundred twelve (112) entries to fill fifteen (15) races. Saturday had one hundred fifteen entries to fill (15) races.

Friday's scratch time was at 9:00 a.m. There were twenty (20) driver corrections, one (1) early scratch, four (4) additions of Lasix, one (1) claiming price removed and one (1) Lasix removed.

08/20/10 (2) **Tenth Race – Claim**

#3 “Above Timberline”, trained by Larry Hasting, was claimed for \$3,750 by Phillip Ray Campbell, Orangevale, California and Liberio Pacheco, Acampo, California.

08/20/10 (3) **Thirteenth Race – Inquiry**

The stewards hung the inquiry for a possible violation of the breaking rule by #5 “Candy Girl”, driven by Robert Stepien, in the stretch. After a review of the incident, the stewards felt Mr. Stepien didn’t lose ground while on the break, thus violating the breaking rule. #5 “Candy Girl” was placed from fourth (4th) to seventh (7th) by the stewards.

08/20/10 (4) **Fourteenth Race – Inquiry**

The stewards hung the inquiry sign for a possible violation of the breaking rule by #5 “Titan Seelster”, driven by James Kennedy before the 3/4 pole. After review, the stewards felt Mr. Kennedy followed the rules and did not violate the breaking rule. There were no changes in the finish.

Saturday08/21/10 (1) **Qualifiers**

Saturday morning there were twenty (20) entries to fill three (3) qualifying races at 4:30 p.m. Saturday afternoon with two (2) scratches leaving eighteen (18) horses to compete. Sixteen (16) horses made qualifying times.

08/21/10 (2) **Fourth Race – Inquiry**

The stewards hung the inquiry sign concerning #2 “Dugout Andee” for possible interference to a number of horses approaching the 3/4 pole. After a long review of the incident, there were two (2) different violations found to have happened.

First, #2 “Dugout Andee”, driven by James Lackey got unmanageable approaching the 3/4 pole, causing interference to trailing horses. For this, #2 who finished fifth (5th), was placed eighth (8th).

Second, while avoiding the first incident, #4 “Western Hurricane”, driven by James Kennedy, left the course but didn’t return to the track until approaching the stretch, instead of returning at a much earlier time where there was room to do so. For this the stewards placed #4 “Western Hurricane” from the fifth (5th) position, where he was placed because of the first incident, to seventh (7th) for leaving the course; a violation of the pylon rule. This type of situation is called a double placing.
