04-20-2018³**INQUIRY-NO CHANGE-2ND RACE**

The Stewards posted the inquiry sign following the second race in order to examine contact in the stretch between #4 Mr. Magico (Irving Orozco) first and #2 Son Of The South (Alejandro Gomez) second.

After considering the patrol judges report, talking with the riders involved and reviewing the video, the Stewards decided unanimously to let the original order of finish stand.

The video shows the two maidens making mutual contact on two occasions in the stretch and did not affect the outcome.

04-20-2018⁴**FILLY PULLED UP-4TH RACE**

#1 Native Jaylo (Trainer Jeff Bonde) was pulled up inside the 1 1/16 pole by Jockey Abel Cedillo. Track Veterinarian Sara Sporer, DVM reported the three year old filly was lame in the right foreleg. Native Jaylo was given a ride home in the horse ambulance.

04-20-2018⁵**CLAIM VOIDED-5TH RACE**

The Stewards voided the claim submitted by Trainer Blaine Wright for the four year old filly Friendly Request (Trainer Jonathan Wong) after the Official Veterinarian Forrest Franklin reported she was lame in the left foreleg. Friendly Request was returned to the Wong barn.

Jockey **JUAN HERNANDEZ** who rode **SILENT MOVIES** in the second race at Golden Gate Fields on Saturday, April 21, 2018 is suspended three (3) racing days (April 29, May 3 and 4, 2018) for failure to make a proper effort to maintain a straight course on the backstretch and causing interference; a violation of California Horse Racing Board rule # 1699 (a), (c) & (e) (Riding Rules-careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

Jockey **HERIBERT MARTINEZ** who rode **FALL HARVEST** in the second race at Golden Gate Fields on Saturday, April 21, 2018 is suspended five (5) racing days (April 29, May 3, 4, 5 and 6, 2018) for failure to make a proper effort to maintain a straight course on the backstretch and causing interference; a violation of California Horse Racing Board rule #1699 (a), (d) and (e) (Riding Rules-careless riding-second offense in the past 60 days).

The term of this suspension shall not prohibit participation in designated races in California.

The above rulings were issued after both riders met the Stewards for a review of their actions during the running of the second race on April 21, 2018.

Both riders were responsible for maneuvers on the backstretch of the one mile event resulting in the unnecessary contact of their respective mounts.

Unfortunately for Mr. Martinez this is his second riding offense in the last sixty days, therefore his suspension will be for five days.
