Jockey Agent **JAY ROBINSON** is fined the sum of Three Hundred Dollars (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to conduct his business in a proper manner on Wednesday April 4, 2018 necessitating a late scratch for the horse **ON FIRE** in the eighth race on Saturday, April 7, 2018.

The above ruling was issued after Robinson came into the Steward's office and accepted responsibility for entering "ON FIRE" for Trainer L. A. Martinez in the wrong race.

ELLEN JACKSON (CASE #18GG0022)

Case dismissed, Ellen Jackson was absolved of responsibility when her former owner took responsibility for having the horse CROWNETHORP moved to Trainer Jonathan Wong's barn after Jackson had entered the horse which caused a late scratch.

04-13-2018³**GRAEME THOMAS RULING (CASE #18660022-REFERENCE 04-13-2018²)****#84**

Owner **GRAEME W. THOMAS (DBA WILLOW TREE FARM, INC.)** is fined the sum of Three Hundred Dollars (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to have the horse **CROWNETHORP** start necessitating a late scratch in the fifth race on Friday, March 23, 2018; a violation of California Horse Racing Board rule #1698 (Failure to Start and Run).

The above ruling was issued after Thomas contacted the Stewards on Sunday April 8, 2018 and accepted responsibility for the scratch of "CROWNETHORP" on March 23, 2018.

04-13-2018⁴**BLAINE WRIGHT- (CASE #18GG0015)**

Warning issued. Trainer Wright employed groom Juan Camacho and gave him money to get his license after putting him on his work list. It was determined during licensing that Camacho had been suspended in 2009 for failure to appear at Bay Meadows. Wright did everything according to the book except asking the Board if he was okay ahead of time.

04-13-2018⁵**FERRIN PETERSON RULING****#85**

Apprentice Jockey **FERRIN PETERSON** who rode **COUNCIL MISS** in the fifth race at Golden Gate Fields on Sunday, April 8, 2018 is suspended three (3) racing days (April 20, 21 & 22, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-careless riding).

The above ruling was issued after Peterson appeared and reviewed the race in question. She realized that she had opened up a hole to her inside leaving room for a rival to get through. As that rival started to go through the hole Ms. Peterson dropped over to the inside closing the hole on the eventual winner.

04-13-2018⁶**3RD RACE LATE SCRATCH**

#2 **OSO STRONG** (Cristobal Herrera) reared in the gate and after a recommendation from Track Veterinarian Sara Sporer "OSO STRONG" was scratched. The scratch reduced the field to four starters which caused show wagering to be cancelled.
