During the term of the suspension, all licenses and license privileges of **DAWN L. CRUMP** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

Jockey **IRVING OROZCO** who rode **ASKIN' FOR TROUBLE** in the fifth race at Golden Gate Fields on Sunday, February 25, 2018 is fined the sum of Three Hundred Dollars (\$300.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond-third offense in the past 60 days).

The above rulings were issued after Orozco once again appeared in the Steward's office for cropping violations. Mr. Orozco admitted to the violations and will contact the paymaster for payment.
