Jockey **JESUS VELAZQUEZ** having appeared for a hearing before the Board of Stewards is restored to good standing and Pacific Racing Association ruling #39, dated December 10, 2017 suspending **JESUS VELAZQUEZ** for violation of California Horse Racing Board rule #1547 (Failure to Appear) is hereby set aside.

Further, jockey **JESUS VELAZQUEZ** is fined the sum of One Hundred Dollars (\$100.00)* for failure to report to the Stewards for film review on December 9 and 10, 2017; a violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers).

Jockey **JESUS VELAZQUEZ** who rode **MARK YE WELL** in the third race at Golden Gate Fields on Friday, December 8, 2017 is suspended three (3) racing days (December 30 and 31, 2017 and January 1, 2018) for altering course without sufficient clearance approaching the far turn and causing interference; a violation of California Horse Racing board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above rulings were issued after Mr. Velazquez finally appeared to view his ride in December 8th's 3rd race. Velazquez admitted to his fault in the race after review. He said he didn't know he could send a representative and had no transportation to get to the racetrack. Mr. Velazquez has been a journeyman

rider for many years and should know better than to "Stand Up" the Stewards without calling or sending a representative.

12-26-2017⁴**7TH RACE DOUBLE INQUIRY-DOUBLE DISQUALIFICATIONS**

The inquiry sign was posted to review two incidents in the 7th race.

First: Shortly after the start #6 Miss Gunny (Julien Couton) was observed bearing out interfering and basically eliminating #7 Windward Storm (Abel Cedillo) from any chance at contending in said race. #6 was disqualified from 5th to 9th for the interference.

Second: In the stretch run #10 Lucky Antares (Ricardo Gonzalez) bears in causing #8 Silken queen (Catalino Martinez) to check sharply and lose any chance at a better placing. #10 was disqualified from 6th to 7th for the interference.

Owner **STEVEN MC PHERSON**, having failed to comply with the terms of a signed payment agreement with Owner Debbie Watson, is hereby suspended for violation of California Horse Racing Board rule #1876 (Financial Responsibility) pending satisfaction of the outstanding financial obligation to Ms. Watson.

During the term of the suspension, all licenses and license privileges of **STEVEN MC PHERSON** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

The above ruling was issued after the Stewards received written notice from owner Debbie Watson that Mr. McPherson failed to honor a payment agreement signed on December 7, 2017.

12-29-2017²**GONZALEZ RULING (REFERENCE #12/26/17⁴)****#4**

Jockey **RICARDO GONZALEZ** who rode **LUCKY ANTARES** in the seventh race at Golden Gate Fields on Tuesday, December 26, 2017 is suspended (3) three racing days

(January 5, 6 and 7, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from sixth to seventh; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Gonzalez reviewed the race in question with the Stewards. Mr. Gonzalez realized his error of failing to correct this mount from drifting in during the stretch drive and accepted the penalty without argument.

Trainer Gary Greiner appeared on two separate cases involving Class IV medication violations. Mr. Greiner wished to have both cases heard today. Investigator Joe Mulligan had no objection and the Stewards agreed to hear the cases in a combined hearing.

Case #17GG0139 was addressed first and concerned a reported high Phenylbutazone of 2.65 ug/ml on the gelding "Extensive" from the sixth race at the Humboldt County Fair on September 3, 2017. Mr. Greiner stated he gives Bute orally 28 or more hours out from the race and has not had any problems.

Case #17GG0150 was heard second and concerned a reported double NSAID of Flunixin 4.2 ng/ml and Phenylbutazone 0.86 ug/ml on the mare "Gunny" who ran in the 5th race on October 14, 2017 at The Big Fresno fair. Mr. Greiner had no explanation for the violation.

Mr. Greiner had a warning issued in October of 2015 for a Phenylbutazone overage.

12-29-2017⁵**JOURNEYMAN RIDER LICENSED**

Jockey Erick Cruz has moved his tack from Illinois to Golden Gate.

Mr. Cruz was made aware of what the Stewards expect of a veteran rider and was given the okay for licensing.

12-29-2017⁶**SIXTH RACE INQUIRY-DISQUALIFICATION**

The inquiry sign was posted to review an incident in the stretch involving 2nd place finisher #3 Taylor's Rose (Rocco Bowen) and fourth place finisher #6 Deanns Mojave (Julien Couton) who was beaten a nose for third place. After review and speaking to the riders, #3 was disqualified from 2nd to 4th in a unanimous decision.

#3 is on the lead and drifts off the rail leaving an opening for #6 to drive up the inside. As #6 makes its move Jockey Bowen corrects #3's drift and comes back into the path of #6 causing Jockey Couton to check his mount.

SATURDAY12-30-2017¹**WINICK RULING****#5**

Trainer **DEBBIE WINICK** is fined the sum of Three Hundred Dollars (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to have the horse **SHE'S IN LUCK** approved from the starting gate necessitating a late scratch in the seventh race on Tuesday, December 26, 2017; a violation of California Horse Racing Board rule #1588 (i) (Horse Ineligible to start in a Race).

The above ruling was issued after Ms. Winick was contacted about entering a horse which did not have starter Todd Stephen's approval. Ms. Winick stated that she was going on word from the exercise rider who told her the horse was okay.

12-30-2017²**GREINER RULINGS (REFERENCE 12/29/17)****#6**

Trainer **GARY D. GREINER**, who started the horse **EXTENSIVE**, second place finisher in the sixth race at the Humboldt County Fair (Ferndale), on September 3, 2017, is fined the sum of Five Hundred Dollars (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, drugs and Other Substances)-Phenylbutazone, in excess of permitted level-2.65 ug/ml [class 4]).

Trainer **GARY D. GREINER**, who started the horse **GUNNY**, third place finisher in the fifth race at the Big Fresno Fair, on October 14, 2017, is fined the sum of One Thousand Dollars (\$1000.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, drugs and Other Substances-more than one approved medication, Phenylbutazone (0.86 ug/ml) and Flunixin (4.2 ng/ml) [class 4] second offense in 365 days) and #1844 (c) (Authorized Medication).

The above rulings were issued using the guidelines spelled out in California Horse Racing board rule #1843.3 (Penalties for Medication Violations) after due deliberation over yesterday's Hearing.

12-30-2017³**VELASCO RULING****#8**

Apprentice Jockey **EDGAR VELASCO** who rode **OKLAHOMA RED** in the third race at Golden Gate Fields on Friday, December 29, 2017 is fined the sum of Three Hundred Dollars (\$300.00)* for violation of California Horse Racing Board rule #1688 (4) (Use of Riding Crop-When the horse has obtained its maximum position).

The above ruling was issued after Velasco appeared and reviewed the race in question. Hopefully, he now fully understands when to restrain from crop usage.

A horse trained by John F. Martin suffered a catastrophic injury this morning.

12-30-2017⁵**BOWEN RULING (REFERENCE 12/29/17⁶)****#9**

Jockey **ROCCO BOWEN** who rode **TAYLOR'S ROSE** in the sixth race at Golden Gate Fields on Friday, December 29, 2017 is suspended three (3) racing days (January 6, 7 and 11, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fourth; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Bowen appeared and reviewed the race in question. Bowen openly admitted to over correcting his mount and causing interference. He accepted the penalty without argument.

12-30-2017⁶**MC CONNELL HEARING CASE #17GG0166)**

An informal hearing was conducted to address a complaint filed against stable foremen Tricia Ann McConnell for violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

The complaint reads:

Stable Foreman Tricia Ann McConnell has been having an on-going feud with trainer Monty Meier and his partner, Owner Donna Perrone. There have been several incidents of shouting and the use of profanities. Golden Gate Fields Security has had to respond on several occasions. As a result, this matter is being referred to Golden Gate Fields Board of stewards for resolution.

Both McConnell and Perrone aired their feelings toward each other. It seemed that part of the problem was the proximity of McConnell's tack room (residence) in relation to the Meier/Perrone barn. Stable Superintendent Carrie Fawcett was summoned and she will help ease the tension by relocating McConnell. The end result was a caution from the Board of Stewards to stay away from each other and discontinue the feud or all parties will be disciplined.

A claim deposited by trainer William E. Morey for the filly "Native Jaylo" was voided by the Stewards after State Veterinarian Forrest Franklin reported the filly lame in the right foreleg and would be placed on the Veterinarian's List. The filly was returned to the barn of trainer Jeff Bonde.

12-30-2017⁹**4TH RACE INQUIRY/ACCIDENT-NO CHANGE**

Shortly after the start of this six furlong event #2 Blackhawk Beauty trained by Jeff Bonde and ridden by replacement rider Kevin Orozco ducked sharply trying to make the main track gap unseating Orozco. "Blackhawk Beauty" then ran into the inside rail and somersaulted over into the infield. Amazingly, all early reports were that horse and jockey avoided any serious injury. Jockey Orozco was taken off his one remaining mount for precautionary reasons on the recommendation of Dr. Seftel even though he reported minor bruising was all he suffered. No change since it was a one horse accident.
