FORMAL HEARING-STEVEN MCPHERSON (CASE #17GG0153)

Owner, Steven McPherson appeared in response to a financial complaint filed against him by owner Debbie Watson. The complaint alleges \$19,693.73 is owed to Ms. Watson for a loan (plus interest) to Mr. McPherson for the purchase of a filly in Kentucky. CSR, Christine Niccoli transcribed the proceedings.

After much discussion the parties agreed to resolve the issue with Mr. McPherson submitting cash or a cashier's check for \$15,000.00 on or before December 11, 2017. Mr. McPherson was advised that failure to abide by the terms of the settlement would result in the suspension of his California Horse Racing Board license.

12-07-2017⁴ **RULING #36-RAXON CHO (CASE #17GG0159)**

Owner **RAXON CHO**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before December 3, 2017, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility).

During the term of this suspension, all licenses and license privileges of **RAXON CHO** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued as Mr. Cho failed to appear in response to a scheduled hearing to address a financial complaint filed against him by San Francisco Equine (Kenneth Allison, DVM). The complaint alleges a debt totaling \$2,660.98 for services rendered.

12-07-2017⁵ **OBJECTION-NO CHANGE-3RD RACE**

The Stewards posted the objection sign following the third race at the request of jockey Abel Cedillo (#7 Amandana-4th), who lodged a claim foul against #3 Sea Myrtle (Julien Couton) second.

After consulting the patrol judge, talking with riders involved and reviewing the video, the Stewards decided unanimously to make the original order of finish official.

The video shows #7 Amandana steady briefly near the 1/16 pole between #3 Sea Myrtle on the outside and #5 Astra Star (William Antongeorgi-fifth) on the inside. The Stewards determined the pressure came from #5 Astra Star who was drifting out slightly. #7 Amandana finished in ahead of #5 Astra Star, so disqualification was not considered.

- 12-08-2017³ **FILM REVIEW**
Jockey William Antongeorgi and the Stewards reviewed the video of the third race from December 7, 2017. Mr. Antongeorgi's mount was drifting out in the stretch and inconvenienced a rival. The veteran rider who did make a satisfactory effort was issued a warning.
- 12-08-2017⁴ **INQUIRY-NO CHANGE-3RD RACE**
The Stewards posted the inquiry sign following the third race for a review of an incident near the 3/8 pole involving four horses.

The video shows #2 Mark Ye Well (Jesus Velazquez) seventh alter course and impede #5 Daddy Duke (Ricardo Gonzalez) sixth, #7 Redneck Crazy (Kevin Orozco) fourth and #8 Yes I', Wild (Hugo Herrera) fifth.

After considering the patrol judges report, talking with the riders involved and reviewing the video, the Stewards decided unanimously to make the original order of finish official as #2 Mark Ye Well, who was responsible for the interference finished behind those he bothered.
- 12-08-2017⁵ **HORSE INJURED-5TH RACE**
#4 Singaprayor (William Antongeorgi) was injured in the first turn of this one mile event and was pulled up by Jockey Antongeorgi. Track Veterinarian Sara Sporer, DVM reported the three year old gelding was unsound behind and walked off the track.
- 12-08-2017⁶ **CLAIM VOIDED-8TH RACE**
The Stewards voided the claim submitted by trainer Andy Mathis for #1 Lord of Chaos (William Antongeorgi) after the Official Veterinarian, Forrest Franklin, DVM, reported the five year old gelding was unsound in the left foreleg.
- 12-08-2017⁷ **HORSE INJURED-8TH RACE**
#4 Endless Mile (Julien Couton) was injured near the 3/4 pole of this one mile turf event and was given a ride home in the horse ambulance. Track Veterinarian Sara Sporer, DVM, reported a fracture of the right hind leg. Trainer Holly Evan' attending veterinarian Kim Kuhlman, DVM euthanized the three year old gelding.

The Stewards conducted a video review for the benefit of the wagering public that showed #8 You Play The Bench (T.P. Queally) break in the air out of the gate.

The Stewards posted the inquiry sign following the ninth race to examine an incident in the stretch involving several horses including the winner #10 Pequena Maty (Silvio Amador).

After considering the patrol judges report, talking with the riders involved and reviewing the video. The Stewards decided unanimously to disqualify #10 Pequena Maty from first to last.

The video shows Pequena Maty alter course near the 1/16 pole forcing #3 Lady Chrome (Rocco Bowen) fifth, to take up sharply and stack up a number of other horses.

Jockey **SILVIO AMADOR** who rode **PEQUENA MATY** in the 9th race at Golden Gate Fields on Saturday, December 9, 2017 is suspended (5) five racing days (December 26, 29, 30, 31, 2017 and January 1, 2018) for altering course without sufficient clearance in the stretch and causing interference resulting in the disqualification of his mount from first to twelfth; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued as Mr. Velazquez once again failed to meet with the Stewards for a review of his ride in the third race on December 8, 2017.
