FRIDAY11-24-2017¹**AMESCUA HEARING (CASE #17GG0127)**

A formal hearing was conducted for trainer Rene Amescua into a complaint alleging that the horse Tale Of Papa Nick, winner of the eighth race at the Sonoma County Fair (Santa Rosa) on August 18, 2017, showed the presence of both Bute and Banamine in the post-race blood sample in violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances).

Present at the hearing, besides the Stewards and Court Reporter Christine Niccoli, were Amescua and California Horse racing Board Investigator Joe Mulligan who presented the case. Amescua acknowledged that the horse was administered Bute by his attending Veterinarian, Steve Boyer the day before the race. Amescua couldn't remember if he treated the horse with Banamine paste but if he did so it would have been given at least 3 days prior to the race.

The presence of Banamine was confirmed by testing the split sample at LGC Science Inc. in Lexington, Kentucky. The Stewards took the evidence and testimony under submission and will render a decision in the near future.

11-26-2017² **STEWARDS INQUIRY-ACCIDENT-FIRST RACE-NO CHANGE**

The Stewards posted the inquiry sign to determine the cause of a spill approaching the 1/8 pole when #5 Sideman, ridden by William Antongeorgi, fell unseating the

jockey. After a thorough review the Stewards affirmed the original order of finish. Tapes showed that Sideman was injured near the 1/8 pole and fell. No other horses were involved. Antongeorgi suffered a contusion to his lower back and was driven to the hospital for precautionary x-rays.

11-26-2017³**STEWARDS INQUIRY-FOURTH RACE-NO CHANGE**

The Stewards illuminated the inquiry lamp once again to review the stretch run of the first two finishers, #7 Lucky Views (1st, Rocco Bowen) and #5 Sheila's Footsteps, (2nd, Abel Cedillo). After a thorough examination the Stewards took no action.

Tapes showed close quarters between the two competitors during a thrilling stretch duel that saw them finish a nose apart but nothing occurred that would warrant the Steward's intervention.

11-26-2017⁴**CLAIM VOIDED-SIXTH RACE**

The claim deposited by trainer Monte Meier for the horse Cherokee In Me in the sixth race was voided when Official Veterinarian Forest Franklin deemed the horse unsound in a post-race examination and put her on the Veterinarian's List. The mare was returned to the care of trainer Blaine Wright.
