Jockey **CATALINO MARTINEZ** is fined the sum of Two Hundred Dollars (\$200.00)* for using the crop after the horse **ROIANNA** had attained her maximum placing in the second race on Sunday, November 5, 2017; a violation of California Horse racing Board rule #1688 (b) (4) (Use of Riding Crop).

The above ruling was issued after Martinez appeared and reviewed the race with the Stewards. He realized he struck his mount too aggressively nearing the finish after obtaining its maximum placing.

11-10-2017³**JOE CRISPIN RULING #22****#22**

Jockey **JOE A. CRISPIN** having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before November 9, 2017, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rules #1500.1 (a) (Random Drug Testing) and #1930 (Obedience to Security Officers and Public Safety Officers).

During the term of this suspension all licenses and license privileges of **JOE A. CRISPIN** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

The above ruling was issued after jockey Joe Crispin failed to appear before this panel to respond to complaint #17GG0145.

11-10-2017⁴**FIRST RACE INQUIRY**

The Stewards ordered the "Inquiry" light to be activated after the running of the first race. A three horse bumping incident prior to the 1/8 pole was being questioned. Video shows the inside horse #1, Shahalie Shari, and the outside horse #3, Terra Lago both being bumped by #2, Shine On Me. The original order of finish 3-1-2 was not impacted therefore there was no change.

11-10-2017⁵**STEWARDS REVIEW 2ND RACE**

A review to the start to determine why Pedro Terrero aboard #1, "Hock" lost his inside iron. Video shows horse took a slight bobble at break and rider fell forward. Jockey regained stirrup at ½ pole but ran last. Horse/rider caused their own troubles.

SATURDAY11-11-2017¹**SANGUINETTI RULING #23****#23**

Jockey ANNE SANGUINETTI who rode **SHINE ON ME** in the first race at Golden Gate Fields on Friday, November 10, 2017 is suspended three (3) racing days November 18, 19 and 23, 2017 for failure to make a proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races within California.

Jockey Anne Sanguinetti attended films with the Stewards to review Friday's 1st race. This panel felt her mount initiated bumping while in the middle of a three-horse spread.

11-11-2017²**TRAINER GREG JAMES VISIT**

Greg James visited asking for guidance in a financial situation with regards to a purchase of four horses. The person who was the middle man is Dan Alameda.

11-11-2017³**JOE CRISPIN APPEARANCE (CASE #17GG0145)**

Jockey Joe Crispin appeared to question ruling #22 issued November 10, 2017 suspending and denying him access. He was sent to the investigator's office to reschedule.

11-11-2017⁵**RACE 3-JOCKEY OBJECTION**

Jockey Julien Couton, who finished second, lodged an objection against the winner ridden by Pablo Flores for impeding him in deep stretch.

Video shows the winner making things tight inside the 1/16 pole; however, it did not affect the outcome. It was unanimous that there would be no change.

11-11-2017⁶**RACE 3-VOIDED CLAIM**

The claim of the winner, Stella Street, was voided when State Veterinarian Forrest Franklin added the mare to the "Veterinarian's List" as unsound. Horse was returned to the care of trainer Anthony Stabile.

11-11-2017⁷**RACE 7-INQUIRY, OBJECTION AND DISQUALIFICATION**

Stewards posted the inquiry sign immediately after the finish. Rider on #2, Abel Cedillo, lodged an "objection" with "Quick Official" outrider against the place horse #5, ridden by Cristobal Herrera.

Video shows #5, La Waun, drifting in on four horses causing two to steady and two to check hard. This panel agreed in disqualifying #5 and placing him last.

SUNDAY11-12-2017¹ **JOCKEY COUTON MEETING**

Jockey Julien Couton stopped by as requested to discuss a matter from the previous day's 3rd race. Mr. Couton had called an objection with the "Quick Official" outrider, which the Board of Stewards posted on the infield board. Replays did not show any interference or problems.

Jockey Couton stated he only wanted to bring attention to the follow rider's bad habits. This panel indicated to him in such cases he should contact the Stewards to talk about those issues opposed to illuminating the objection sign.

11-12-2017² **CRISTOBAL HERRERA RULING #24****#24**

Jockey **CRISTOBAL HERRERA** who rode **LA WAUN** in the seventh race at Golden Gate Fields on Saturday, November 11, 2017 is suspended three (3) racing days November 19, 23 and 24, 2017 for crossing over without sufficient clearance on the backstretch and causing interference resulting in the disqualification of his mount from second to sixth; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding). The term of this suspension shall not prohibit participation in designated races within California.

The above ruling was issued after jockey Herrera met with the Stewards and viewed video from Saturday's 7th race which resulted in his mount being disqualified.
