10-26-2017⁴**RULING #9-SILVIO AMADOR****#9**

Jockey **SILVIO AMADOR** is hereby fined the sum of Three Hundred Dollars (\$300.00)* for striking his mount on the head during the running of the first race on Sunday, October 22, 2017; a violation of California Horse Racing Board rule #1688 (b) (1) (Use of Riding Crop).

Jockey Silvio Amador met with the Stewards regarding his ride on Sought More Pep (Trainer Alex Paszkeicz) in the first race on October 22, 2017. Mr. Amador stated he was trying to get his mount's attention when he struck her twice on the ear. He was advised that striking his mount anywhere on the head is in violation of the rules.

10-27-2017³**FINANCIAL COMPLAINT CASE #17GG0144)**

The financial complaint filed against owner Mersad Metanovic by Trainer Jerry Hollendorfer has been dismissed as the Stewards were advised the debt (\$9,070.82) for training has been satisfied.

10-27-2017⁴**FORMAL HEARING-IRVING OROZCO (CASE #17GG0142)**

A formal hearing was held this morning for jockey Irving Orozco who has been charged with alleged violation of California Horse Racing Board rules #1489 (a) & (b) (Grounds for Denial or Refusal of License), #1900 (Grounds for Suspension or Revocation) and #1902 (Conduct Detrimental to Horse Racing).

Present for the hearing were Mr. Orozco, who waived his right to counsel, and the Board of Stewards (Meyers, Herbuveaux and Nevin). California Horse Racing Board Investigator Joe Mulligan presented the case and Certified Shorthand Reporter Christine Niccoli recorded the proceedings.

According to the complaint "on the above date (10-08-2017) The Big Fresno Fair Board of Stewards requested that Jockey Irving Daniel Orozco be randomly tested for any illegal drug use. A urine sample was voluntarily obtained at which time the results revealed that he tested positive for both Cocaine and Marijuana.

Testimonial and documentary evidence was submitted for the record and the hearing was closed.

10-27-2017⁵ **RULING #10-MILTON PINEDA (CASE #17GG0014)****#10**

Owner **MILTON PINEDA** having satisfied the outstanding financial obligation to San Francisco Equine, Inc. is hereby restored to good standing and Pacific Racing Association ruling #43 dated February 16, 2017 suspending **MILTON PINEDA** for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside.

The above ruling was issued after the Stewards were notified in writing that Mr. Pineda has satisfied his debt (\$529.00) to Steven Boyer, D. V. M.

10-27-2017⁶ **RULING #11-OWNER/TRAINER DARLENE BRADEN (CASE #17GG0132)**
RULING #12-OWNER KELSEY R. SKINNER (CASE #17GG0135)

The foregoing rulings were issued after both Ms. Skinner and Ms. Braden requested and were granted a telephonic hearing. Ms. Skinner acknowledged administering the Phenylbutazone orally through a tube and believed she did so in a timely fashion on the morning the day prior to the race. Ms. Skinner did say she had treated another horse that morning in the same manner and perhaps residue in the tube caused the high reading. She went on to say she accepted responsibility for the violation. Ms. Braden, who authorized the administration accepted responsibility as the trainer of record.

Owner/Trainer **DARLENE M. BRADEN**, who started the horse **KATSTHOUGHT**, second place finisher in the seventh race at the Humboldt County Fair (Ferndale) on August 27, 2017, is fined the sum of Five Hundred Dollars (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone-in excess of permitted level 5.03 ug/ml, class IV).

Owner **KELSEY R. SKINNER** who owned the horse **KATSTHOUGHT**, second place finisher in the seventh race at the Humboldt County Fair (Ferndale) on August 27, 2017, is fined the sum of Five Hundred Dollars (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone-in excess of permitted level 5.03 ug/ml, class IV).

10-27-2017⁷ **INQUIRY-NO CHANGE-1ST RACE**

The stewards posted the inquiry sign following the first race to review an incident near the 5/16 pole. #2 Ultra Code (Rocco Bowen) racing along the rail inside a four horse spread, steadied, dropped back and eventually finished last.

After consulting with the patrol judges, talking with the riders and reviewing all video angles, the Stewards decided unanimously to make no change in the original order of finish.

Video's failed to place the blame on any other horse and the original order of finish was made official.

10-29-2017³ **TRACK VETERINARIAN-TRAINER MEETING (REFERENCE 10-28-2017³)**
Following the running of the first race yesterday (10-28-2017) the winner Seal Six (Trainer Rene Amescua) was observed leaving the Winner's Circle by Track Veterinarian Sara Sporer, who determined the six year old gelding was unsound in the left foreleg. The horse ambulance was summoned and Seal Six was given a ride home.

It later came to the Stewards attention that a somewhat heated discussion took place between Mr. Amescua and Dr. Sporer.

The Stewards met with the two today regarding their professionalism, or lack thereof. Also present was Golden Gate Fields Corporate Executive David Duggan.

Mr. Amescua stated he had no objection to Dr. Sporer's observation of Seal Six, or her calling for the horse ambulance. However, he did take exception to her demand that Mr. Amescua's groom turn the horse over to her aide while awaiting the ambulance.

Dr. Sporer concurred with Mr. Amescua's account, stating it was standard operating procedure for her aide to assist in loading an infirm horse. Both agreed the situation could and should have been handled in a more professional manner. The two respected licensees denied any use of foul language which was of major concern to the Stewards and Mr. Duggan and will not be tolerated.

10-29-2017⁴**CLAIMS VOIDED-8TH RACE**

Two claims submitted by trainer Jonathon Wong for different owners were voided following a report from the State Veterinarian Forrest Franklin, DVM.

Solomon Bay (Trainer Jack Steiner) was unsound in the left foreleg and returned to the Steiner barn. Pepper Crown (Trainer Ed Moger) was off in the right foreleg and went back to the Moger barn.
