09-17-17³ **RULING #15 – SHERRY STANLEY (17GG0128)**

The foregoing ruling was issued as Ms. Stanley failed to appear for a scheduled hearing regarding the financial complaint against her by the San Francisco Equine Veterinary Group. The complaint alleges and outstanding debt totaling Twenty-Five Hundred and Eighty Dollars (\$2,580.00).

Ruling #15

Owner/Trainer **SHERRY STANLEY**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before September 16, 2017, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rules #1876 (Financial Responsibility).

During the term of this suspension, all licenses

and license privileges of Sherry Stanley are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

09-17-17⁴ **RULING #16 – LELAND McGEE (17GG0129)**

Ruling #16

Owner **LELAND McGEE**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before September 16, 2017, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rules #1876 (Financial Responsibility).

During the term of this suspension, all licenses and license privileges of Leland McGee are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued as Mr. McGee failed to appear for a scheduled hearing regarding the financial complaint filed against him by San Francisco Equine alleging a debt totaling Twenty-Nine Hundred Dollars (\$2,900.00).

09-17-17⁵ **CLAIM VOIDED**

The Stewards voided the claim submitted by Trainer John Martin for the seven year old gelding CALIFO CATE (Tr. Samuel Calvario) after the Official Veterinarian Forrest Franklin, DVM, reported CALIFO CAT was unsound in the right foreleg and was placed on the veterinarian's list. CALIFO CAT was returned to the Calvario barn.
