OROZCO HEARING-CASE 16GG0052

Jockey Irving Orozco appeared to answer charges of a urine positive for Marijuana in the amount of 63 ng/ml. The threshold level is 50 ng/ml for Quest Labs to call a positive. Mr. Orozco stated that he had smoked Marijuana approximately three weeks prior to giving a test sample. Mr. Orozco agreed to take another test today. A decision will be rendered following receipt of results of the test. Mr. Orozco has had a history of drug abuse but has been trying to straighten out his life. He has been attending meetings and is under contract with the Winners Foundation. Nora Lee was present and will keep this Board informed of Mr. Orozco's progress, decision to follow.

FRIDAY05-13-2016¹ **ARRIAGA RE-INSTATEMENT (REF 05/06/2016²)****#102**

Jockey **Jesus Arriaga** having made arrangements to satisfy the outstanding financial obligation to the Paymaster of Purses at the Sonoma County Fair (Santa Rosa) is hereby restored to good standing and Pacific Racing Association ruling #98, dated May 6, 2016, suspending Mr. Arriaga for violation of California Horse Racing Board rule #1760 (Purse Award or Prize to Be Withheld) is set aside.

The above ruling was issued after Arriaga paid half the debt today and agreed to pay the other half next week.

05-13-2016² **MEDINA HEARING CASE 16GG0019 (REF 04/23/2016¹-04/22/2016²)**

A formal hearing was finally held today concerning the misappropriation of a riding crop by Jockey Luis Medina.

Present at the hearing was Jockey Luis Medina along with his current (new) attorney Brian Pitnick. California Horse Racing Board Counsel Phillip Laird presented the case. Investigator Louis Quezada and Jockey Barrington Harvey testified on behalf of the Board. Steve Lozano was sworn in as interpreter for Mr. Medina.

This case has been delayed on three previous occasions with Mr. Medina being suspended on April 23, 2016 for failing to appear after allegedly missing a flight from Washington State. Mr. Medina has been suspended since that date.

The primary facts in the case are that Mr. Medina claimed a crop turned in by the track crew as his own and he took possession of it. It was subsequently discovered that the crop possibly belonged to fellow rider Barrington Harvey. After extensive investigation, investigator Louis Quezada revealed that the crop in question was in fact jockey Harvey's. Quezada's testimony indicated that Medina was not immediately forthcoming with information concerning the riding crop by insisting it was his and given to him by Jockey Silvio Amador. Mr. Medina related through his attorney that he accepts the fact the riding crop is not his. Jockey Harvey was given the crop at the conclusion of the hearing.

Medina for violation of California Horse Racing Board rule #1547 (Failure to Appear) is hereby set aside and the license privileges of Mr. Medina are restored to good standing.

Further Mr. Medina is fined the sum of One Hundred Dollars (\$100.00)* and suspended fifteen (15) days for violation of California Horse Racing Board rule #1902 (Conduct Detrimental to Horse Racing-Misappropriation of Property). With respect to the suspension, Mr. Medina is given credit for time served.

The above ruling was issued after weighing the facts presented in yesterday's hearing.

Perennial leading rider Russell Baze returned to the saddle today after a long layoff due to a broken collar bone. Baze, true to form, won on his first mount back when he piloted odds on favorite Lizzy Marini to victory in today's fourth race for trainer Jonathan Wong.

The inquiry sign was posted to review an incident in deep stretch involving the first place finisher #4 Bay Area (Catalino Martinez) and fourth place finisher #10 Village Kitten (Alejandro Gomez). After talking to the riders and reviewing the video, #4 was placed fourth for interference to #10. The decision was unanimous. Video replay clearly shows #4 come out under left handed urging causing Jockey Gomez to check #10 Village Kitten and get out finished for third place by an inch by #8 Cackle The Cuda (Joe Crispin).
