The above ruling was issued after Mr. Baze visited the Steward's office and accepted the penalty.

MARKLE RULING**#67**

Trainer **Dan Markle** is hereby fined the sum of One Hundred Dollars (\$100.00)* for failure to follow proper procedures when declaring the horse **Weyand** will race unshod in the Seventh race on Sunday, March 27, 2016; a violation of California Horse Racing Board rule #1853 (Examination Required).

The above ruling was issued after Markle contacted the Stewards and accepted the penalty for the mix up.

CRISPIN RULING**#68**

Jockey **Joe Crispin** who rode **Tosheen** in the second race at Golden Gate Fields on Sunday, March 27, 2016 is suspended three (3) racing days (April 7, April 8 and April 9,

2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The above ruling was issued after Crispin came in and reviewed films and argued his side. He felt that he made every effort to keep his horse straight in the stretch but the horse drifted on its own. The Stewards felt he was pushing his horse in an effort to win and failed to straighten his mount before interfering with #2 "Lota Spunk" (Cristobal Herrera) who finished a strong third.

The above ruling was issued after the Stewards at Santa Anita contacted this Board verifying that purse monies owed had been paid by Navarro.

Exercise rider **Bobbie J. Brown** is fined the sum of Fifty Dollars (\$50.00)* and placed on probation for the term of her license (11-30-2016) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct) on January 16, 2016.

The above ruling was issued after deliberation over Ms. Brown's actions to sidestep one investigator for another. Further, this Board was informed Ms. Brown's urine test showed the presence of Methamphetamine and Amphetamine. Ms. Brown has requested a split sample and that matter is pending until further notice.

Owner **Ugo De La Torre** having repaid the purse monies to the Paymaster of Purses as required by Pacific Racing Association ruling #9, dated January 16, 2016, is restored to good standing and Pacific Racing Association ruling #59, dated March 24, 2016 suspending **Mr. De La Torre** pursuant to California Horse Racing Board rule #1760 (Purse or Prize Award to Be Withheld) is hereby set aside.

The above ruling was issued following written verification from State Fair Paymaster Vickie Layne that De La Torre paid his portion of the purse monies back

04-01-2016⁴ **OROZCO RULING****#72**

Apprentice **Jockey Kevin Orozco** who rode **Misty Bay** in the fourth race at Golden Gate Fields on Thursday, March 31, 2016 is suspended three (3) racing days (April 8, April 9 and April 10, 2016) for failure to make a proper effort to maintain a straight course on the backstretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after young Orozco reviewed the race with the Stewards, Orozco felt a little pressure was put on his outside by the six horse but accepted the fact he caused interference to the eventual winner.

04-01-2016⁵ **YATES HEARING-CASE 16GG0008**

A hearing was held today for association employee Ann Dee Yates who failed to appear on February 19 and was suspended on February 20 per ruling #29. Ms. Yates admitted to Marijuana use and wished to try and turn her life around through the help of Winners Foundation.

The case was presented by Investigator Louis Quezada. Trainer Ron White was present as moral support for Ms. Yates and Nora Lee of Winners foundation was on hand. Mr. Quezada had groom Miranda Gramlich and exercise rider Lance Grenamyre in attendance as well. The complaint was strictly against Yates but Gramlich and Grenamyre are involved in bickering with Yates, according to Quezada, and he asked that they be warned to cease and desist.

Ms. Yates will be evaluated by Nora Lee of the Winners Foundation and a ruling will be forthcoming following her report.

The Stewards posted the inquiry sign to review two incidents in the stretch drive involving five of the six participants in the race.

The first incident concerned #5 Sea Of Magic and apprentice rider David Martin baring and impeding #4 She's My Cookie (Joe Crispin) and #6 Donut Talk To Me (William Antongeorgi III). Both horses that were interfered with finished in front of #5 so there was no reason for a disqualification. Mr. Martin will appear in the Stewards office tomorrow.

The second incident concerned #1 Silver Ice and Jockey Kyle Frey coming out in deep stretch causing Jockey Barrington Harvey to check #3 Safe World, stopping his momentum and costing him any chance at a better placing. #1 finished second and was disqualified and placed fifth behind #3 for the interference.

Association Employee **Anndee L. Yates** is hereby fined the sum of One Hundred Dollars (\$100.00)* and placed on probation through December 31, 2016 for violation of California Horse Racing Board rule #1874 (Disorderly Conduct-Use of Marijuana) on January 21, 2016.

As conditions of probation Ms. Yates must abide by the terms of a testing agreement with the California Horse Racing Board and the terms of a contract with the Winners Foundation. Failure to comply with the terms of probation will result in action taken against Ms. Yates license privileges.

Further Pacific Racing Association ruling #29, dated February 20, 2016 suspending **Ms. Yates** for violation of California Horse Racing Board rule #1547 (Failure to Appear) is hereby set aside.

The above ruling was issued after deliberating over yesterday's hearing and receiving an evaluation from Nora Lee of the winners Foundation.

Jockey **Kyle Frey** who rode **Silver Ice** in the second race at Golden Gate Fields on Friday, April 1, 2016 is suspended five (5) racing days (April 9, 10, 14 15, and 16, 2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Frey appeared and accepted the penalty. He received five days because his last set of days was just recently completed in late February.

Apprentice Jockey **David Martin** who rode **Sea of Magic** in the second race at Golden Gate Fields on Friday, April 1, 2016 is suspended three (3) racing days (April 9, 10, and 14, 2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after young Mr. Martin appeared and candidly admitted to

causing interference. He now realizes that he needs to put the crop away and straighten his mount before making contact with other horses.

SUNDAY04-03-2016¹ **ELOY NAVARRO RULING – (REF 02/11/2016²)****#76**

Acting on an order of remand following the adoption of a proposed decision by the California Horse Racing Board, Trainer **Eloy Navarro** who started the horse "**Dont Walk Peacefully**", second place finisher in the third race at the California Exposition and State Fair on July 24, 2015 is hereby suspended sixty days (April 8, 2016 through June 6, 2016) and fined the sum of Five Thousand Dollars (\$5000.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing rule #1843 (a) & (d) (Medication, Drugs and Other substances; Prohibited Substance Clenbuterol [Class 3]) and #1843.1 (a) (Prohibited Medication).

During the term of suspension, all licenses and license privileges of **Eloy Navarro** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises within this jurisdiction. All horses trained by **Mr. Navarro** are denied entry pending a transfer approved by the Board of Stewards.

The above ruling was issued after receiving adaptation by the California Horse Racing Board of the proposed decision of case 15SW0043 on March 29, 2016.
