AUGUSTIN RAYAS RULING**#46**

Horseshoe inspector **Augustin Rayas** is fined One Hundred Dollars (\$100.00) for failing to notify the Stewards of an improperly shod horse prior to the sixth race on March 6, 2016. A violation of California Horse racing Board rule #1555 (Duties of Horseshoe Inspector).

The above ruling was issued after Rayas appeared before the Stewards and had no good reason why he didn't contact the Stewards with a shoe discrepancy which led to an eventual late declaration in Sunday's sixth race. Mr. Rayas has been substituting for regular horseshoer inspector Oliver (Butch) Fyllingness and was a little confused on his records. Hopefully our discussion and guidance will insure no further problems. Steward Nevin felt the penalty should have been stronger.

FRIDAY03-11-2016¹ **HOLLENDORFER RULING (REF 03/10/2016¹)****#47**

Trainer **Gerald "Jerry" Hollendorfer** is hereby fined the sum of Three Hundred Dollars (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to follow proper procedures when declaring a change that his horse will race with shoes necessitating a late scratch for the horse **Yahoo Tahoe** in the sixth race on Sunday, March 6, 2016; a violation of California Horse Racing Board rule #1853 (Examination Required).

The above ruling was issued after a telephonic conversation between Mr. Hollendorfer and the Stewards. The issue arose at five minutes to post that the horse "Yahoo Tahoe" had shoes on and raced last time without them. By the time the discrepancy was verified as a violation of the rules the Stewards felt it was too late to rectify the situation for the race and the horse was declared. Mr. Hollendorfer understood his part in failing to declare shoes on but felt the race should have been held up to give him the option of having the shoes pulled so the horse could race.

03-11-2016² **6th RACE-STEWARDS REVIEW**

The Steward's reviewed the stretch drive of the sixth race to observe the actions of #6 Flying Tee (Russell Baze). #6 was steered to the inside to avoid traffic and over reacted by ducking slightly. #6 went on to win and no reason was found to hang the inquiry sign.

Owner **Paul Michael Kypros**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before March 11, 2016, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rules #1930 (Obedience to Officers and Public Safety Officers), #1902 (Conduct Detrimental to Racing) and #1874 (Disorderly Conduct).

During the term of this suspension, all licenses and license privileges of **Paul Michael Kypros** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued when Mr. Kypros failed to appear for yesterday's hearing. The complaint stems around problems track security has had with owner Kypros.

Young Orozco wisely took up when he ran out of options. Since no other horses were at fault no inquiry was necessary. Mr. Orozco will visit the Stewards for counseling on how to avoid problems of this sort in the future.

03-13-2016³ **TOTE BOARD MALFUNCTION**

The Tote Board malfunctioned off and on from the beginning of the card. This included the time of day and post time unavailability. All personnel were instructed to use the

post times posted in the program to assure a smooth program. Mutuel manager Doug Gooby agreed that would be the best course of action. A leaky roof on the Tote-Board shorting out key wiring was noted as the cause. The system was back on line for the 7, 8 and 9th races.
