Jockey **Hugo Herrera** who rode **Tiz Titus** in the eighth race at Golden Gate Fields on Sunday, January 31, 2016 is suspended three (3) racing days February 11, 12 & 13, 2016 for altering course without sufficient clearance and causing interference in the stretch. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The above ruling was issued after Mr. Herrera and the Stewards reviewed the video of the eighth race from Sunday January 31, 2016.

Mr. Herrera admitted he erred when he altered course and caused interference.

02-04-2016⁴ **FILM REVIEW**

Jockey Russell Baze and the Stewards reviewed the video of the third race from Sunday, January 31, 2016.

Mr. Baze's mount Our Princecharming was disqualified from third to fifth as his crop struck a rival on the nose horse while racing in tight quarters in the stretch.

The Stewards determined the incident was accidental and did not require any disciplinary action.

02-05-2016³ **RULING #18-KYLE FREY****#18**

Jockey **Kyle Frey** who rode **Roman Wild** in the fifth race at Golden Gate Fields on Thursday, February 4, 2016 is fined the sum of One Hundred Dollars (\$100.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The foregoing ruling was issued after Mr. Frey met with the Stewards and acknowledged he violated the crop rule as he struck his mount four consecutive times in the stretch. This is Mr. Frey's first offense in the last sixty days.

02-05-2016⁴ **OSCAR DANIEL YOGUES (16GG0007)**

Groom Oscar Daniel Yagues appeared in response to a complaint filed by California Horse Racing Board investigator Louis Quesada. The complaint reads in part, "Groom Oscar created a large disturbance while inside his tack room while on the backside of Golden Gate Fields. Security Personnel contacted the Berkeley Police Department and took the subject into custody for a psychiatric evaluation. Per Berkeley Police Department, the subject appeared under the influence of a controlled substance".

The incident noted in the complaint occurred on January 15, 2016 and Mr. Yagues was transported by ambulance to John George Psychiatric Hospital in Oakland for evaluation.

The Stewards requested and Mr. Yagues agreed to provide a urine sample. In addition, the troubled groom will provide information regarding the psychiatric evaluation and Berkeley Police Department's disposition of his case.

02-05-2016⁵ **INQUIRY-NO CHANGE-2ND RACE**

The Stewards posted the inquiry sign following the second race for a review of the stretch run. After a thorough review of the video and interviewing the riders involved, the Stewards decided unanimously to make the original order of finish official, as the incident did not affect the outcome. The video shows #2 Wild Atlantic Way, (Alejandro Gomez), on the inside of a three horse spread, initiate contact with #4 I Came To Party (Kyle Frey) second, who in turn made contact with #6 Drouillard (Juan Hernandez) fourth.

02-05-2016⁶ **STEWARDS REVIEW-4TH RACE**

The Stewards conducted a review of the start of the fourth race for the public that shows #3 What A Rainbow (Alejandro Gomez) sixth, duck in sharply and cause its rider to lose contact with his irons. Jockey Gomez was able to get back into the irons a short time later.

Golden Gate Fields Track Physician David Seftel, M.D., notified the Stewards that Mr. Crispin has serious medical conditions that were discovered during the annual physicals all jockeys must undergo and until these issues are addressed, the veteran rider is unfit to ride.

Mr. Crispin was advised to consult with Dr. Seftel and adhere to whatever recommendations he provides in order to be cleared to ride.

02-06-2016⁴ **RULING #19 LUIS E. MARISCAL (15GG0116)****#19**

Owner **Luis E. Mariscal** dba **Cuadra Mariscal** is hereby suspended pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to Be Withheld) for failure to repay purse monies to the Paymaster of Purses as required by Pacific Racing Association #29 dated November 22, 2015.

The above ruling was issued after the Stewards were notified by the California Fair Circuit Paymaster of Purses, Vickie Layne, that Mr. Mariscal has not repaid the purse money ordered returned subsequent to a Clenbuterol positive.

A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The above ruling was issued after Mr. Frey and the Stewards reviewed the video of the sixth race from February 6, 2016. Mr. Frey acknowledged he was careless in allowing his mount to drift into the path of a rival causing interference. Both horses were in the back of the field and the incident had no bearing on the outcome.
