01-23-2016² **EVANS DECISION (REFER 01-22-2016²)****# 13**

Trainer **Holly J. Evans** is fined the sum of One Hundred Dollars (\$100.00)* for failure to follow proper procedures when declaring the horse **Studhammer** unshod in the third race on Monday, January 18, 2016; a violation of California Horse Racing Board rule #1853 (Examination Required).

The above ruling was issued following yesterday's informal hearing. Although Evans offered several reasons why the shoe information was not carried on the program none of them absolved her of the responsibility to supply that data for public dissemination.

01-23-2016³ **FILM REVIEW**

Apprentice jockey Cerapio Figueroa viewed the tapes of yesterday's last race and was cautioned about riding crop use in the stretch when his mount was well off the lead. The Stewards issued a warning rather than a penalty as the incident was minor.

01-23-2016⁴ **FINANCIAL RESOLVED (CASE #16GG002)**

A financial complaint filed by trainer James Meredith against owner Steve Martinez was resolved between the parties before the matter reached the Stewards for hearing.

01-23-2016⁵ **STEWARDS INQUIRY-SEVENTH RACE-NO CHANGE**

The Stewards illuminated the inquiry sign to review the start of #6 Myheartsinthecity ridden by Luis Medina after the horse hopped out of the starting gate and caused Medina to lose his balance and fall. The Stewards determined that no other horses were involved and affirmed the original order of finish. Neither horse nor rider suffered any ill effects from the incident.

01-24-2016² **FILM REVIEW**
 Jockey Hugo Herrera viewed tapes of yesterday's third race and was cautioned to look before he changes lanes. He put a rival in close quarters at the top of the stretch when he moved inside searching for racing room.

01-24-2016³ **LATE SCRATCH-THIRD RACE-REFUND**
 #3 Minister Vivende, trained by Debbie Winick, was scratched by the Stewards when the horse reported to the receiving barn with no hind shoes. Rule #1853 requires that when a horse races unshod and it is a change from the previous race it must be declared at entry time so the information can be listed in the program for the benefit of the wagering public. Failure to provide such information makes the horse ineligible to start. The refund amounted to \$1,321.60.

01-24-2016⁴ **STEWARDS REVIEW-THIRD RACE**
 The Stewards conducted a review after #1 Ernest Shackleton, trained by Doug O'Neill and ridden by Ricardo Gonzalez, bolted to the outside rail while racing around the far turn. Track veterinarian Sarah Sporer was on the scene and reported the horse went wrong in the right front. The gelding was given a ride back to the barn and placed on the Veterinarian's List as well as the Steward's List.

01-24-2016⁵ **VOIDED CLAIM-FIFTH RACE**
 A claim deposited by trainer Tim McCanna for the third place finisher #3 Sunset Skies was voided by the Stewards after official veterinarian Forrest Franklin placed the horse on the Veterinarian's List following the race. Sunset Skies was returned to the barn of trainer Ed Moger.
