03-20-15³**OWNER MARTIN V. OROZCO – RULING #54****RULING#54**

Owner **MARTIN V. OROZCO** having now appeared for a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers) is hereby restored to good standing and Pacific Racing Association ruling # 36, dated February 26, 2015, suspending Mr. Orozco for violation of California Horse Racing Board rule #1547 (Failure to Appear) is hereby set aside.

The preceding ruling was issued after Mr. Orozco and representatives of Golden Gate Fields met with the Stewards and addressed CHRB complaint 15GG0021. Mr. Orozco was cited in the complaint for being uncooperative and belligerent toward security officers. After listening to both parties regarding the matter a warning was issued.

03-20-15⁴**7TH RACE INQUIRY – DISQUALIFICATION**

Following the running of 7th race the inquiry sign was posted for a review of observed interference in the stretch involving #5 SWEET SILICA (1st place - jockey Ricardo Gonzalez), #6 TANNED MISTRESS (2nd place – jockey Kyle Frey), and #7 PATTI D'MARIE (3rd place – jockey Barrington Harvey).

After talking with the jockeys involved and reviewing the recorded views of the incident, #6 was disqualified from 2nd place to 3rd.

The recordings show #6 drift outward then shift out further, while under left hand whip, into the path of #5 which was forced into the path of #7 causing significant interference to both horses. #5 overcame the interference and won the race, however #7 was deprived of opportunity of better placing which resulted in the disqualification of #6. The decision was unanimous.

03-21-15³**JOCKEY KYLE FREY – RULING #55****RULING#55**

Jockey **KYLE FREY**, who rode **TANNED MISTRESS** in the seventh race at Golden Gate Fields on Friday, March 20, 2015 is suspended three (3) racing days (March 28 and 29, April 2, 2015) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to third: A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The term of this suspension shall not prohibit participation in designated races.

The ruling listed above was issued after Mr. Frey reviewed the race with this Board and candidly acknowledged his error.

03-22-15³ **6TH RACE INQUIRY / DISQUALIFICATION**

The inquiry was posted following the running of the sixth race for a review of interference near the wire involving #1 AALSMEER (1st place – jockey Kyle Frey) and #6 TIZ POINT (4th place – jockey Juan Hernandez).

After reviewing all the recorded views and talking to the riders involved, #1 was disqualified from 1st to 4th. The recordings show #1, who appeared to have the race won, steadily drift inward into the path of #6 forcing the rider of #6 to take up while avoiding heels and lose an opportunity of a better placing. The decision was unanimous.

03-22-15⁴ **9TH RACE – JOCKEY OBJECTION**

An objection was filed following the running of the ninth race by jockey Pedro Flores who rode #3 LUCKY POINT (7th place) against #6 MILLENNIUM BREW (2nd place – jockey Pedro Terrero) for alleged interference near the sixteenth pole.

After talking to the riders involved and reviewing the recordings of the race, no change was made to the posted order of finish. The recordings show #3, while dropping back after racing on the lead, sustain minor contact from #6 as that rival stepped inward while going through an opening along the rail. The decision of the Stewards was unanimous in that the placings were not affected.
