11-14-14³**SAN FRANCISCO EQUINE vs. JAMEY THOMAS (14GG0091)**

A formal hearing was held this morning to address a financial complaint filed by San Francisco Equine against Owner/Trainer Jamey Thomas alleging a debt for services rendered totaling \$18,196.84.

Present in addition to Stewards Herbuveaux, McHargue and Nevin were Mr. Thomas, Veterinarians Ken Allison D.V.M. and Kim Kuhlmann D.V.M. representing San Francisco Equine and their bookkeeper Susan Kennedy. Certified Shorthand Reporter Christine Niccoli reported the proceedings.

After a lengthy presentation of documents and arguments, it was suggested we take a break and encouraged the parties to discuss a compromise. The agreement they came back with called for Mr. Thomas to pay two hundred and fifty dollars per month on a total reduced to nine thousand. Mr. Thomas signed a financial agreement with the understanding that his failure to comply will result in the suspension of his license.

11-14-14⁴**INQUIRY – DISQUALIFICATION – 2ND RACE**

The Stewards posted the Inquiry sign following the second race for a review of an incident in the stretch involving #3 DUBLIN DANCER (Kyle Frey) third and #4 INSIDE SCOOP (Ricardo Gonzalez) who finished fifth.

After reviewing the video and interviewing the riders involved, the Stewards decided unanimously to make no change in the original order of finish.

The video shows #3 DUBLIN DANCER bumps INSIDE SCOOP in mid-stretch. However, the latter was tiring and the incident, in the Stewards opinion, did not affect the outcome.

11-15-14³**RULING #16 – KYLE FREY**

Jockey **KYLE FREY** who rode **DUBLIN DANCER** in the second race at Golden Gate Fields on Friday, November 14, 2014 is suspended three (3) racing days (November 22, 23 and 27, 2014) for failure to make a proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules - Careless Riding).

The foregoing ruling was issued after Mr. Frey and the Stewards reviewed the video of the second race from November 14, 2014.

Mr. Frey offered little excuse for allowing his mount to drift out under left handed whipping and impeding a tiring rival.

11-15-14⁴**INQUIRY – NO CHANGE – 2ND RACE**

The Stewards posted the Inquiry sign following the second race for a review of an incident near the 3/16 pole involving #3 BLUE BLIZZARD (Russell Baze) first and MUM'S KEE (David Lopez) second.

After interviewing the riders involved, considering the patrol judges report and reviewing the video, the Stewards decided unanimously to make no change in the original order of finish.

The video shows #7 MUM'S KEE shied from #3 BLUE BLIZZARD as they entered the top of the stretch and the latter was not responsible for any interference.

11-15-14⁵**SIXTH RACE DELAY - ACCIDENT**

The sixth race was delayed approximately seven minutes due to an accident during the parade to the post.

#1 PRIVATE JOKE was acting up, threw his head back and injured jockey Russell Baze. PRIVATE JOKE was returned to the paddock for a replacement rider (Kyle Frey). Track Physician David Seftel reported Baze suffered a deep laceration over his left eye and would be off for the remainder of the day.

Of course #1 PRIVATE JOKE went on to win the sixth race.

11-15-14⁶**STEWARDS REVIEW – 6th RACE**

The Stewards conducted a review of the sixth race to show the public what occurred near the ¼ pole.

The video shows #4 MAMBO ROCK (Frank Alvarado) drifted in slightly while backing up on the turn and caused #7 FLASH OF LIGHTNING (Carson Sullivan) to steady briefly. The latter went on to finish in front of the former, negating the need for an Inquiry.

RULING #17 – JAY FREY

Exercise rider Jay Frey met with the Stewards in response to a complaint from the morning outriders alleging his failure to adhere to the protocol following a training accident and his disrespectful attitude directed toward one of those outriders.

In addition to Mr. Frey, outriders Nancy Barney and Bob Anderson were present to explain what occurred this morning.

The outriders explained that Mr. Frey failed to pull up the horse he was on and rode right through an accident scene near the finish line. They went on to explain that the track warning lights were on indicating there was an accident on the track and the clockers made announcements over the speaker system that the horse ambulance was on the track. In addition, Mr. Frey made a crude remark to Ms. Barney when he rode past her.

Mr. Frey stated he did not see the track morning lights or hear the announcements. He further stated he only saw the horse ambulance when it was too late to pull up. Mr. Frey did not recall making any statement to Ms. Barney. The following ruling was issued.

Exercise Rider/Valet **JAY FREY** is fined the sum of three hundred dollars (\$300.00)* for failure to follow proper protocol while emergency procedures were in effect during the morning workout hours and for using abusive language toward an outrider on November 16, 2014; a violation of California Horse Racing Board rules #1437(Conditions of a Race Meeting) and #1874 (Disorderly Conduct).

Jockeys Russell Baze and Kyle Frey were excused from their mounts today as both were injured in separate riding incidents.

Mr. Baze was injured during the parade to the post for the sixth race yesterday and has not recovered. Mr. Frey went down in a training accident this morning and injured his wrist.
