SECURITY MEETING

The Stewards met with members of Golden Gate Fields Management regarding stable area security. Present for the meeting were Assistant General Manager Calvin Rainey, Director of Operations Bob Hemmer, Security Manager T.W. Johnson, Stable Superintendent Carrie Fawcett, Security Sergeant Mike Miles, California Thoroughbred Trainers Representative Charles Dougherty, California Horse Racing Board Investigator Louis Quezada and Safety Steward Paul Nicolo.

A number of issues were discussed, but primarily, the amount and quality of Security in the stable area during the night. It was the consensus that more

“on foot” patrols are necessary and, if possible, additional manpower. It was revealed that the two roaming stable area guards are occasionally called to another area of the facility (grandstand, north parking area, etc.) to address an issue. This leaves the stable area unsecured, except for the gate guards. This is unacceptable and it was suggested that additional manpower was needed.

Shockwave Therapy: There were two shockwave therapy treatments reported.
