11-21-13⁴**ACCIDENT – INQUIRY – 6th RACE**

The Stewards posted the inquiry sign following the sixth race for a review of a serious spill that occurred inside the 1/8 pole.

#7 HAMMURABI (Tr. Francisco Flores) ridden by C.H. Aragon, fractured his right front fetlock and fell into the path of #3 KOOKY SALUKI (Tr. Jim Penney), who stumbled and fell with Jockey William Antongeorgi III.

Track Veterinarian Sara Sporer D.V.M., euthanized HAMMURABI on the track. KOOKY SALUKI was examined by Trainer Jim Penney's Veterinarian, Steve Matuszak D.V.M., who determined the gelding suffered a fractured shoulder and was subsequently euthanized off the track.

11-23-13³**GARY D. GREINER – (13GG0106) (13GG0120)**

A formal hearing was held to address two complaints filed against Owner/Trainer Gary D. Greiner for alleged violations of California Horse Racing Board rules #1887 (Trainer to Insure Condition of Horse), #1843 (a) and (d) (Medication, Drugs and Other Substances) and #1844 (c)(2).

Mr. Greiner was advised of his right to counsel and agreed go forward without representation. Certified Shorthand Reporter (CSR) Christine Niccoli recorded the proceedings. According to the evidence and testimony presented Mr. Greiner ran the horse "THERE GOES KEVIN," on two occasions at the Humboldt County Fair (Ferndale). On August 14, 2013 "THERE GOES KEVIN" finished fourth in the second race and the post race blood sample (F10508) showed the presence of Flunixin (Banamine) at a level of 110 ug/ml. (Case #13GG0106) "THERE GOES KEVIN" ran again at Ferndale on August 25, 2013 and the post race blood sample taken following his winning effort in the sixth race, showed the presence of Flunixin (Banamine) at a level of 50.7ng/ml.

The Stewards voided a claim submitted by trainer Jim Baumgartner for HEARTLESS HONEY as State Veterinarian Forrest Franklin, DVM reported the filly was unsound in her right foreleg. The filly was returned to Trainer William Spawr's barn.

11-24-13⁴**INQUIRY – SIXTH RACE – NO CHANGE**

The Stewards posted the Inquiry sign following the sixth race for a review of the stretch drive.

After interviewing the riders involved, and reviewing the video, the Stewards, by majority decision (McHargue dissenting), determined the incident approaching the finish did not affect the outcome.

The video shows #7 MILK MAN RAY (Jockey – Catalino Martinez), who finished second, drifts out into the path of #2 FASTER THAN DUKE (Jockey – Frank Alvarado) fourth, causing the latter to check briefly.

11-24-13⁵ **OBJECTION – NINTH RACE – NO CHANGE**

The Stewards lit the Objection sign at the request of Jockey Kyle Frey, who finished third on #4 FLYING MARINE. Mr. Frey lodged a claim of foul against #6 CANDY'S JEWEL (Jockey – Russell Baze) second, alleging interference near the 3/16 pole.

After conferring with the Patrol Judges, interviewing the riders involved and reviewing the video the Stewards decided unanimously that there was nothing to warrant a disqualification.
