10-23-13<sup>1</sup>

#### ENTRIES AND DECLARATIONS

Steward John Herbuveaux was in attendance today to oversee entries and declarations and will continue with those duties for the remainder of the week.

#### Thursday

10-24-13<sup>1</sup>

#### CAL- BRED REPORT

Purse \$9,500. For California bred or California sired three year olds and upward, claiming \$4,000 at one mile. The race was called off with one entry.

10-24-13<sup>2</sup>

#### OWNER MYLES R. MCMAHON – RULING 07

Owner **MYLES R. MCMAHON**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before October 20, 2013, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of CHRB rule #1876 (Financial Responsibility).

The ruling listed above was issued after Mr. McMahon failed to appear to address a debt of \$2,705.37 allegedly owed to Equine Sports Medicine and Surgery Inc. (Dr. Don Smith).

#### JOCKEY KYLE FREY – RULING 08

Jockey **KYLE FREY** who rode **MOUNTAIN YODLER** in the sixth race at the Big Fresno Fair on Monday, October 14, 2013 is suspended three (3) racing days (October 31, November 1 and 2, 2013) for failure to maintain a true course coming out of the far turn into the stretch and

causing interference; a violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules - Careless Riding).

The foregoing ruling was issued after Mr. Frey met with this Board of Stewards following an infraction that occurred during the running of the sixth race on the last day of racing at the Fresno County Fair.

After reviewing the recording it was clear Mr. Frey left himself in an indefensible position when he allowed his mount, which was racing near the inside rail, to drift out past the middle of the track forcing the horse on his outside off its path and causing that rival to lose considerable ground.

**JOCKEY FRANK ALVARADO – RULING 09**

Jockey **FRANK ALVARADO** who rode **ENGLISH LACE** in the eighth race at Golden Gate Fields on Sunday, October 20, 2013 is suspended three (3) racing days (October 31, November 1 and 2, 2013) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules - Careless Riding).

The preceding ruling was issued after Mr. Alvarado reviewed the race in question with this Board and failed to offer an excusable reason for his continued use of a left hand whip after his mount started drifting outward and caused interference.

**INQUIRY 1<sup>st</sup> RACE – DISQUALIFICATION**

Following the running of the first race the inquiry sign was posted for a review of a foul down the backstretch involving #7 FASTER CAT (1<sup>st</sup> place – jockey Juan Hernandez), #4 AT LAST A WILDCAT (5<sup>th</sup> place – jockey Angel Sanchez), #3 ALL ABOUT ADAM (4<sup>th</sup> place – jockey Catalino Martinez), #2 KNOWN ASSOCIATE (6<sup>th</sup> place – Jockey Maggie Hardison) and #1 DEFENSIVE MOVE (7<sup>th</sup> place – jockey Abel Cedillo).

After talking to the riders involved and reviewing the recording #7 was disqualified from 1<sup>st</sup> to 7<sup>th</sup>.

The recordings show #7 cross over, without clearance, approaching the half mile causing interference to #4, #3, #2 and #1 costing those rivals better placings. The decision was unanimous.

**CLAIM VOID – SECOND RACE**

The claim for #7 FASTER CAT (Tr. Quinn Howey) was voided after the horse was examined by the State Veterinarian and placed on the Vet’s list.

10-24-13<sup>8</sup>

**INQUIRY – SECOND RACE - DISQUALIFICATION**

Following the running of the second race the inquiry sign was lit once again for a review of an incident involving #3 COLONEL CLARK (4<sup>th</sup> place – jockey Juan Hernandez) and #6 WALTZTOTHEWINDOW (5<sup>th</sup> place – jockey Leslie Mawing) near the sixteenth marker.

After reviewing the recording of the incident #3 was disqualified from 4<sup>th</sup> to 5<sup>th</sup>. The recordings show #3 veer in sharply into the inside rail and rebounded off the rail causing interference to #6, costing that rival a chance of a better placing. The vote of the decision was unanimous.

10-25-13<sup>3</sup>**JOCKEY JUAN HERNANDEZ – RULING 10**

Jockey **JUAN HERNANDEZ** who rode **FASTER CAT** in the first race at Golden Gate Fields on Thursday October 24, 2013 is suspended five (5) racing days (November 2, 3, 7, 8 and 9, 2013) for altering course without sufficient clearance on the backstretch and causing interference resulting in the disqualification of his mount from first to seventh. A violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The ruling listed above was issued after Mr. Hernandez and his agent met with the Stewards, reviewed the race and failed to convince the Stewards the riders on his inside were at fault. The recordings clearly show Mr. Hernandez's mount at fault when he was crossing over without clearance.

10-25-13<sup>4</sup>**EXERCISE RIDER LORENZO V. OCHOA****RULING NO.11**

Exercise Rider **LORENZO V. OCHOA**, is fined the sum of one hundred dollars (\$100.00)\* for failure to obey the outriders during morning workout hours; a violation of California Horse Racing Board rule #1870 (Conditions of Meeting Binding upon Licensees).

The foregoing ruling was issued after Mr. Ochoa and outriders Nancy Barney and Dennis Anderson met with the Stewards regarding Mr. Ochoa's continued failure to comply with their request that he not gallop his mount when backtracking. For safety reasons horses are only allowed to walk or jog when backtracking.

10-25-13<sup>5</sup>**INQUIRY – DISQUALIFICATION – SEVENTH RACE**

Following the running of the seventh race the inquiry sign was posted for a review of contact through the stretch involving #1 GLOBAL WARMING (1<sup>st</sup> place – jockey

Ricardo Gonzalez) and #2 ONNA BUGEISHA (4<sup>th</sup> place – jockey Alejandro Gomez). #4 UNUSUAL CLASS (2<sup>nd</sup> place – jockey Juan Hernandez) was also involved in the inquiry after it stepped inward near the wire.

After talking to the riders involved and reviewing the recordings of the race, #1 was disqualified from 1<sup>st</sup> to 4<sup>th</sup>.

The recordings show #1 drift out and make contact repeatedly through the stretch with #2 eventually placing that rival in tight quarters between #1 and #4, forcing the rider of #2 to check, lose position and a chance of a better placing. #4 was held blameless for its actions near the wire.

The decision was unanimous.

**RICARDO GONZALEZ RULING – NO. 12**

Apprentice Jockey **RICARDO GONZALEZ** who rode **GLOBAL WARMING** in the seventh race at Golden Gate Fields on Friday October 25, 2013 is suspended three (3) racing days (November 2, 3 and 7, 2013) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to fourth. A violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The preceding ruling was issued after Mr. Gonzalez and his agent, Ron Freitas, met with the Stewards, reviewed the race and acknowledged guilt.

10-26-13<sup>4</sup>

**MIGUEL ANGEL GARCIA (Case: 13GG0119) and FRANCISCO TORRES ESPINOZA (Cases: 13GG0118 and 13GG0135)**

A combined hearing was held today to address the three cases listed above. Mr. Garcia was cited for alleged violation of 1489 (h) (Grounds for Denial or Refusal of License), 1874 (Disorderly Conduct) and 1890 (Possession of Contraband). Mr. Espinoza was cited for alleged violation of 1874 (Disorderly Conduct) and 1489 (h) (Grounds for Denial or Refusal of License).

In attendance were this Board, Dennis Nevin, John Herbeuveaux and Darrel McHargue, Mr. Espinoza, Mr. Garcia, Winners Foundation representative Armando Colero and California Horse Racing Board Investigator Louis Quezada.

The hearing process was brief as both parties acknowledged guilt of being under the influence of Methamphetamine with Mr. Garcia also having ¼ ounce of Marijuana in his possession and Mr. Espinoza having a glass Methamphetamine pipe in his possession. After testimony was completed and the necessary documents were placed in the record the matter was submitted for decision.

10-26-13<sup>5</sup>**JOCKEY OBJECTION- 9<sup>TH</sup> RACE – NO CHANGE**

The Objection sign was lit following the running of the 9<sup>th</sup> race after Jockey Kyle Frey, rider of the 2<sup>nd</sup> place finisher, lodged an objection against the winner #2 HANDFUL OF PEARLS (jockey – Cristobal Herrera) for interference inside the 1/16 marker.

After talking to the riders involved and reviewing the race, the numbers posted were made official.

The recordings show the rider on #7 steady his mount briefly as the #2 horse crossed its path. However, in the opinion of the Stewards, the incident was minor and insufficient to effect placings.

The decision was unanimous.

Groom **FRANCISCO T. ESPINOZA** is suspended sixty (60) days, October 29 through December 27, 2013 and placed on probation for the term of his license (06-30-2014) pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or

Revocation) for violation of CHRB rule #1489 (h) (Grounds For Denial or Refusal of License – use of Methamphetamine) on September 8, 2013. Prior to reinstatement of his license privileges Espinoza must submit to an evaluation with the Winners Foundation, abide by any recommendations from that organization acceptable to the Board of Stewards and submit a clean test sample. Further, the terms of probation require that Espinoza must sign a testing agreement with the CHRB.

RULING NO. 14

Having now appeared and a hearing having been held Groom **MIGUEL A. GARCIA** is hereby suspended sixty (60) days, October 29 through December 27, 2013 and placed on probation for the term of his license (01-31-2014) pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for violation of CHRB rule #1489 (h) (Grounds For Denial or Refusal of License – possession and use of Marijuana and use of Methamphetamine) on September 8, 2013. Prior to reinstatement of his license privileges Garcia must submit to an evaluation with the Winners Foundation, abide by any recommendations from that organization acceptable to the Board of Stewards and submit a clean test sample. The terms of probation require that Garcia must sign a testing agreement with the CHRB.

Further, Pacific Racing Association ruling #6, dated October 20, 2013 suspending Groom **MIGUEL A. GARCIA** for violation of California Horse Racing Board rule #1547 (Failure to Appear) is hereby set aside.

The foregoing rulings were issued after the Stewards reviewed the evidence presented yesterday at the hearing and deliberated the matter.

**GROOM JORGE RUIZ-GUZMAN**

RULING NO.15

Groom **JORGE RUIZ-GUZMAN**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before October 26, 2013, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of CHRB rule #1874 (Disorderly Conduct).

The ruling listed above was issued after Mr. Guzman missed his hearing date. The complaint alleged Mr. Guzman was in possession of 2.4 ounces of Marijuana and for being under the influence of Marijuana and Methamphetamine. Mr. Guzman was seeking reinstatement of his license and was asked to submit a test sample that returned positive for the drugs listed above.

**INQUIRY – DISQUALIFICATION – 7<sup>th</sup> RACE**

Following the running of the 7<sup>th</sup> race the inquiry sign was posted for a review of the observed interference inside the 1/16 marker between #1 STOP THE CLOCK (2<sup>nd</sup> place – jockey Kyle Frey), #7 DREAMIN GRAND (4<sup>th</sup> place – jockey Leslie Mawing), #9 DAYJUR HOOQ (5<sup>th</sup> place – jockey Abel Cedillo) and #10 SHERIFF BUFORD (3<sup>rd</sup> place – jockey Frank Alvarado).

After talking to the riders involved and reviewing the recordings #1 was disqualified from 2<sup>nd</sup> to 5<sup>th</sup>.

The recording shows chain reaction bumping and crowding from the inside as #1 STOP THE CLOCK drifts out into #7 forcing #9 in tight quarters between #7 and #10 forcing the rider of #9 to take up, lose position and an opportunity of a better placing.
