6-13-13⁵ **RULING #86 – PATRICK A. GLEASON (13GG038)**

In the Matter of:
Owner/Trainer Patrick A. Gleason

Having failed to satisfy the court judgment to Green Valley Training Center in the amount of six thousand eight hundred sixty-two dollars and eighty cents (\$6862.80) by June 9, 2013 as ordered in Pacific Racing Association ruling #64, dated May 10, 2013 the license privileges of Patrick A. Gleason are suspended pending such payment for violation of California Horse Racing Board rule #1876 (Financial Responsibility).

The above ruling was issued as Mr. Gleason failed to satisfy his debt to Green Valley Training Center.

6-13-13⁶ **RULING NO. 87 – JOCKEY VICTOR ESPINOZA**

Jockey **VICTOR ESPINOZA** is fined the sum of fifty dollars (\$50.00)* for reporting late to the jockey's room on Sunday, June 9, 2013; a violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report).

The above ruling was issued as Mr. Espinoza failed to appear and offer a valid excuse for reporting late to the jockey's quarters on Sunday, June 9, 2013.
