4-4-13³ **JOCKEY CHRISTIAN SANTIAGO REYES RACE REVIEW**
Jockey Christian Santiago Reyes was issued a warning after reviewing Sunday's fifth race with the Stewards. Mr. Reyes gave a candid analysis of his actions and provided assurances that he will keep his mounts on a straight course. Time will tell.

4-4-13⁴ **3rd RACE – INQUIRY / OBJECTION**
Following the running of the 3rd race the inquiry sign was posted for review of the stretch run involving #7 ACKMAN (2nd place – jockey Julien Couton) and #6 BIG SWIG (1st place - jockey Joe Crispin). An objection was also lodged by jockey Julien Couton against the winner. After talking to the riders involved and reviewing the recordings of the incident, no change was made to the order of finish.

The recordings show #7 ACKMAN cause interference after drifting inward while under the right hand whip and bump and impede #6 BIG SWIG near the wire.

4-4-13⁵ **CATASTROPHIC INJURY / CLAIM VOIDED**
During the running of the 7th race, near the 4 ½ furlong pole, while racing near the rear of the field, #8 NATIVE THUNDER sustained a severe injury to its right foreleg and was pulled up. After examination by track veterinarian Dr. Sarah Sporer the horse was euthanized at the scene.

Pursuant to California Horse Racing Board rule #1658 (b) (Vesting of Title to Claimed Horse) a claim that was submitted for the horse was deemed void.

4-5-13¹ **CAL-BRED REPORT**
Purse \$20,000. For California bred or California sired three year olds, claiming \$20,000 at one mile. Only two entries were received and the race was called off.

4-5-13² **JOCKEY PEDRO FLORES – RULING NO. 44 (reference 3/30/13²)**
Jockey **PEDRO FLORES** is suspended for one year, retroactively from March 7, 2013 through March 6, 2014 and placed on probation for the term of his license (12-31-2014) pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for violation of California Horse Racing Board rules #1489(h) (Grounds for Denial or Refusal of License), #1498 (Physical Examination), and #1874(4) (Disorderly Conduct) after submitting a urine sample on March 3, 2013, which showed the presence of the prohibited substances Amphetamine and Methamphetamine (Fourth Offense).

Prior to the reinstatement of his license privileges, Mr. Flores must demonstrate a history of a sober and drug free life style acceptable to the Board of Stewards. Mr. Flores must also sign a one year contract with the Winners Foundation going forward from the date his license privileges are restored. Condition of probation includes the signing of a Testing Agreement with the California Horse Racing Board which will be valid during the term of this, or any subsequent Board license held by Mr. Flores.

Should Mr. Flores fail to abide by the terms of either the contract with the Winners foundation or the Testing Agreement with the California Horse Racing Board he will be summarily suspended and his case referred to the California Horse Racing Board with the recommendation that his license be revoked.

Further, Pacific Racing Association ruling #30, dated March 7, 2013, summarily suspending Mr. Flores pending a hearing before a Board of Stewards is hereby set aside.

During the term of suspension, all licenses and license privileges of **PEDRO FLORES** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The preceding ruling was issued after this Board contacted Mr. Flores and discussed the ruling. He was also instructed on the procedures of appealing the matter if he was inclined to do so.

GROOM ISRAEL GARCIA – RULING NO. 45

Groom **ISRAEL GARCIA**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Friday, April 5, 2013, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1874 (1) (2) (4) [Disorderly Conduct] and 1902 [Conduct Detrimental to Horse Racing].

During the term of suspension, all licenses and license privileges of ISRAEL GARCIA are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued after Mr. Garcia failed to appear to address allegations of violation of California Horse Racing Board rule 1874 (1) (2) (4) [Disorderly Conduct] and 1902 (Conduct Detrimental to Horse Racing). Mr. Garcia was cited after he was arrested for fighting with Golden Gate Fields security and trespassing.

OWNER ROBERT J. JASMIN – RULING NO. 46

In the Matter of: Owner Robert J. Jasmin

Having satisfied the outstanding financial obligation to San Francisco Equine, Inc. the license privileges of owner Robert J. Jasmin are restored to good standing and Pacific Racing Association ruling #7 dated September 15, 2012 suspending Mr. Jasmin for violation of California Horse Racing Board Rule #1547 (Failure to Appear) is set aside.

The ruling listed above was issued after notification was received from Lisa Rodrigues, representing San Francisco Equine Inc., that Mr. Jasmin has paid his debt of \$612.00 in full.

JOCKEY JULIEN COUTON – RULING NO. 47

Jockey **JULIEN COUTON** is fined the sum of one hundred dollars (\$100.00)* for unprofessional conduct in the jockey's room following the running of the third race on April 4, 2013; a violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

The preceding ruling was issued after Mr. Couton and Ken Sjoldal (Clerk of Scales) met with the Stewards regarding Mr. Couton's temper tantrum following Thursday's non disqualification decision (3rd race). Interestingly, Mr. Couton lost his temper for an incident in a race in which he was the one who caused the interference.

4th RACE – JOCKEY OBJECTION

Following the running of the 4th race the objection sign was lit after jockey Frank Alvarado, rider of the 2nd place finisher #4 UNUSUAL MEETING, lodged an objection against #6 HEAT STREAKER (1st place – jockey Russell Baze) for interference in the stretch.

After talking to the riders involved and reviewing the race no change was made to the order of finish.

The recordings show both horses contribute to the incident, near the 1/16 pole, as #6 drifted out while #4 drifted in and they crossed paths.

4-6-13⁷

INQUIRY 8th RACE – NO CHANGE

The inquiry sign was posted following the running of the 8th race for a review of an incident near the 3/16 pole involving the lead horse #1 CHARLEMAGNE WOOD (7th place – jockey Abel Cedillo).

After a thorough review the race was made official. The recordings show #1 CHARLEMAGNE WOOD, while racing on the lead and looking like an easy winner, veer to the left and nearly hit the inside rail. The horse temporarily lost its action, dropped back to last and finished in that position. No other horses were involved.

JOCKEY ANTHONY AYALA

Jockey Anthony Ayala came to the office seeking clarification of ruling #18, which was issued against him on November 22, 2012. In the ruling, Mr. Ayala was suspended 120 days and ordered to submit to an evaluation by the Winners Foundation prior to being restored to good standing. Mr. Ayala presented an evaluation report, done by a behavioral health specialist with the Stanislaus County Health and Recovery Services, which stated Mr. Ayala needed to attend additional treatment services. He was instructed to contact the Winners Foundation and submit to their evaluation.
