The hearing for trainers **Alex Paszkeicz** and **Jacob Aguilar** will be rescheduled for the meet at Pleasanton.

The stewards illuminated the inquiry sign to evaluate an incident at the 5/16 when #2 FOLLOW THE CROWD (4th, Aaron Gryder) checked his mount while racing between horses. After a thorough review the stewards affirmed the original order of finish.

Tapes showed that Gryder took back when #4 ROLL YOUR EYES (1st, Frank Alvarado) stepped in. While the incident was serious, because Gryder was forced over the leader's heels, the placings were not affected. Both jockeys will review the tapes with the stewards in the morning.

06-15-12¹ **FILM REVIEW – RULING NO. 84**

Jockeys **Frank Alvarado** and **Aaron Gryder** were in to review yesterday's first race. Both were cautioned to give other riders sufficient room especially since the fields are so short. Tapes showed that Alvarado allowed his mount to step in at the 5/16 and, in doing so, put Gryder's mount on the leader's heels. The stewards issued the following ruling:

Jockey **FRANK ALVARADO**, who rode **ROLL YOUR EYES** in the first race at Golden Gate Fields on Thursday, June 14, 2012, is suspended three (3) racing days (June 21, 22, and 23, 2012) for failure to maintain a true course around the far turn and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

	The stewards posted the inquiry sign to evaluate contact between #4 ELAINE'S TENACITY (2 nd , Irving Orozco) and #6 BREAKFASTATDODI'S (6 th , Francisco Duran) at the top of the stretch. After a thorough investigation the stewards left the original placings intact. Tapes showed that ELAINE'S TENACITY drifted out as the field turned for home and made contact with BREAKFASTATDODI'S. Although a foul occurred the placings were not affected. Jockey Orozco will view the tapes of the race with the stewards in the morning.

06-16-12² **FILM REVIEW / RULING NO. 85 – CARRERO / RULING NO. 86 – OROZCO**

Jockeys **Victor Carrero** and **Irving Orozco** viewed the tapes of yesterday's races with the stewards. Carrero drifted in at the 5/8 during the sixth race and put three horses to his inside in tight quarters causing contact between those three. In the fourth race Orozco drifted out at the top of the stretch and forced a rival out over heels. Neither jockey's explanation could exonerate him from culpability for his respective incident and the following rulings were issued:

Jockey **VICTOR CARRERO**, who rode **HE DID** in the sixth race at Golden Gate Fields on Friday, June 15, 2012, is suspended three (3) racing days (June 23, 24 and 28, 2012) for altering course without sufficient clearance down the backstretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

Apprentice Jockey **IRVING OROZCO**, who rode **ELAINE'S TENACITY** in the fourth race at Golden Gate Fields on Friday, June 15, 2012, is suspended three (3) racing days (June 23, 24 and 28, 2012) for altering course without sufficient clearance at the head of the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

06-16-12³ **STEWARDS' INQUIRY – Fifth Race – NO CHANGE**

The stewards lit the inquiry sign to examine the start after jockey Juan Hernandez parted company with #1 THEY CALL HIM EL shortly after the starting gate stall doors opened. Tapes showed that the horse ducked in causing Hernandez to lose his balance and fall. Neither horse nor rider suffered any ill effects from the incident. Pursuant to the regulations, the horse was deemed a starter and Todd Stephens will require the horse to school in the gate prior to its next race.

06-17-12² **STEWARDS' INQUIRY – Seventh Race – NO CHANGE**

The stewards posted the inquiry sign to evaluate the start of #4 LATIN COFFEE after the horse was extremely late leaving the gate. After a thorough review the stewards affirmed the original placings. Tapes showed that LATIN COFFEE whipped his head simultaneous to the starting gate stall doors opening and then got his head behind the dividing bar in between the #3 stall. The starting gate doors opened properly and the assistant starter turned LATIN COFFEE's head loose so the horse was deemed a starter even though he spotted the field about a sixteenth of a mile at the start.
