The above referenced case was re-opened this morning for the record to allow Mr. Miyadi the opportunity to have the split sample tested. Mr. Miyadi received a split sample test form and was informed the record would remain open for at least 72 hours of if he decides to have the sample tested until the test results are returned. Pursuant to the split sample rule, he has 72 hours from this date in which to decide to have the sample tested. 03-31-12⁴ **ACCIDENT – INQUIRY – Sixth Race**

Following the running of the sixth race the inquiry sign was posted for a review of an accident involving #6 HANG ON IN THERE, ridden by jockey Ronald Richard. After reviewing the various recorded views the race was made official.

The recordings show jockey Richard lose his balance and fall from his mount when the horse stumbled after breaking inward and shift outward at the start. No other horses were involved and neither the horse nor the rider sustained injuries.

04-01-12³ **RULING NO. 54 – KEALY**

Horse Identifier **PATRICK KEALY**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Saturday, March 31, 2012, to answer charges alleging violation of California Horse Racing Board rules #1521 (Responsibility to the Board), #1554 (Duties of Horse Identifier) and #1853 (a) (Examination Required), is hereby suspended pending an appearance for a hearing before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of PATRICK KEALY are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The preceding ruling was issued after Mr. Kealy failed to appear to address charges that he misidentified several horses prior to their races. The complaint states the errors were caught and corrected by the receiving barn staff prior to the horses leaving for the saddling paddock.
