01-16-11(3) RULING NO. 10 – VELAZQUEZ

Apprentice Jockey JESUS VELAZQUEZ is fined the sum of one hundred dollars (\$100.00)* for failure to ride his mount in the fifth race on January 2, 2011; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The foregoing ruling was issued after Mr. Velazquez appeared and apologized for failing to call in for permission to be excused from his mount on January 2, 2011.

01-16-11(4) INQUIRY – NO CHANGE – Eighth Race

The stewards posted the inquiry sign following the eighth race for a review of an incident in the stretch involving #2 UPSTAIRS MAID (Alice Cartwright), first and #3 SMOKIN VALENTINE (Hector Romero), fifth.

After interviewing the riders involved and reviewing the patrol judge's report and the tapes of the race, the stewards decided unanimously to make no change in the original order of finish.

The tapes show #2 UPSTAIRS MAID drift out slightly under a right handed whip, just as #3 SMOKIN VALENTINE takes a step in and steadies briefly near the 1/8 pole. The incident was minor and did not warrant a disqualification.

01-21-11(3) RULING NO. 11 – MATOS (10GG0223)

Trainer GIL MATOS, who started the horse HIGH N DEEP, winner of the ninth race at Golden Gate Fields on November 13, 2010, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Prohibited substance – Dexamethasone [Class 4]).

The above ruling was issued after Mr. Matos appeared and acknowledged a mix up at the barn resulting in the wrong horse receiving the medication.

01-21-11(4) RULING NO. 12 – THOMAS (Refer: 01-17-114)

Trainer DAVID E. THOMAS is fined the sum of fifty dollars (\$50.00) for failure to follow Golden Gate Fields fire regulations on January 12, 2011 which constitutes a violation of California Horse Racing Board rule #1928 (c) (Fire Regulations).

This ruling was issued following the hearing based on a security complaint alleging the violation of the fire safety regulations. Mr. Thomas acknowledged the violation and will not repeat the indiscretion.

01-21-11(5) RULING NO. 13 – STEPHENS (Refer: 01-15-115)

Starter TODD E. STEPHENS is fined the sum of five hundred dollars (\$500.00) for violation of California Horse Racing Board rule #1695 (To the Post – wrong post positions) for the eighth race on Friday, January 21, 2011.

The foregoing ruling was issued following a hearing held on January 15th when Mr. Stephens accepted responsibility for the two horses being loaded in the wrong post positions for the eighth race on January 14, 2011.

01-22-11(3) RULING NO. 14 – MEIER

Trainer MONTY R. MEIER, who started the horse JOHNNY THE WATCH, third place finisher in the sixth race at Golden Gate Fields on November 14, 2010, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Unapproved Substance – Methocarbamol – [Class 4]).

The above ruling was issued after Mr. Meier appeared in response to a California Horse Racing Board complaint alleging violation of CHRB rules #1887 (Trainer to Insure Condition of Horse) and #1843 (Medication, Drugs and Other Substances).

Mr. Meier acknowledged he was treating his horse, JOHNNY THE WATCH, with Robaxin (methocarbamol) for muscle soreness and believed he had stopped the treatment in a timely fashion.

01-22-11(4) ACCIDENT – INQUIRY – NO CHANGE – Third Race

The stewards posted the inquiry sign following the third race to review an accident near the $\frac{3}{4}$ pole.

The tapes show #2 CALIFORNIA BLUE (Francisco Duran) went wrong and while being pulled up was bumped by #6 MORAGA (Pedro Flores), who unseated her rider.

Track veterinarian Heather Kerr reported CALIFORNIA BLUE appeared to have suffered a cracked pelvis and was unable to stand. The four year old filly was euthanized on the track by Dr. Kerr. #6 MORAGA was uninjured, as well as both riders.
