The stewards issued an apprentice certificate and California Horse Racing Board license to **Olmedo N. Pitti** as he meets the qualifications articulated in CHRB rules #1499 (Qualifications for Jockey) and #1500 (Apprentice Jockey).

Mr. Pitti, who is seventeen years old, provided satisfactory notarized documentation that his mother and father approved and grant permission for him to be licensed in the United States.

Mr. Pitti won his first race on January 18, 2009, his fifth winner was on April 2, 2009 and his last (33rd) winner on June 21, 2009, all in Panama. His apprenticeship will start retroactively to the date of his fifth winner (4-2-09) and terminate one year from that date, or his fortieth winner, whichever comes later.

11-27-09³**INQUIRY – DISQUALIFICATION – First Race**

The stewards posted the inquiry sign following the first race for a review of an incident in the stretch involving **#5 HIT THE TOWN** (4th, **Jorge Ayarza**), **#8 GLOBAL DESTINY** (7th, Barrington Harvey) and **#3 PURE SILVER** (5th, Russell Baze).

After considering the patrol judges' report, interviewing the riders involved and reviewing the tapes of the race, the stewards decided unanimously to disqualify **#5 HIT**

THE TOWN from fourth to fifth.

The tapes show #5 HIT THE TOWN drifts out near the 1/8 pole and forces #8 GLOBAL DESTINY to alter course and into the path of #3 PURE SILVER, who had to check sharply. #8 GLOBAL DESTINY was not impeded.

11-28-09³ **RULING NO. 20 - AYARZA** (Refer 11-27-09⁴)

Jockey **JORGE AYARZA**, who rode HIT THE TOWN in the first race at Golden Gate Fields on Friday, November 27, 2009, is suspended three (3) racing days (December 5, 6 and 9, 2009) for failure to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from fourth to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Ayarza and the stewards reviewed the tapes of the first race from Friday, November 27, 2009.

Mr. Ayarza's mount HIT THE TOWN was disqualified from fourth to fifth position for drifting out and causing interference in the stretch.

Mr. Ayarza acknowledged he erred in allowing his mount to continue to drift while not clear of other horses.

11-28-09⁴ **RULING NO. 21 – SCHERPENBORG** (09GG203)

In the Matter of:

Owner **ARNOLD H. SCHERPENBORG**

Having failed to abide by the terms of a financial payment agreement with San Francisco Equine, Inc., owner **ARNOLD H. SCHERPENBORG** is hereby suspended pending satisfaction of the debt for violation of California Horse Racing Board rule #1876 (Financial Responsibility).

During the term of suspension, all licenses and license privileges of ARNOLD H. SCHERPENBORG are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after the stewards received documentation from **San Francisco Equine, Inc.**, that Mr. Scherpenborg failed to comply with the financial payment agreement he signed in order to satisfy the complaint filed against him by S. F. Equine (balance owed \$838.00).

11-28-09⁵ **INQUIRY – NO CHANGE – Fifth**

The stewards posted the objection sign following the fifth race at the request of jockey Modesto Linares (2nd, #7 CHAMPALI LACE), who claimed foul against #5 MARKAY CREEK (Hector Romero), the winner.

After considering the patrol judges' report, interviewing the riders involved and reviewing the tapes of the race, the stewards decided unanimously to make no change in the original order of finish.

The tapes show #7 CHAMPALI LACE runs somewhat erratic and caused his own problems in the stretch.

11-28-09⁶ **ACCIDENT – LATE DECLARATION – Ninth Race**

There was a four minute delay in the start of the ninth race as #2 SUMMER COMET (Diego Sanchez) flipped and injured himself and his rider.

SUMMER COMET was scratched and the ambulance attended to jockey Sanchez, who did not appear to be seriously injured.
