RULING HRTH #029

Pursuant to a stipulated agreement Veterinary Assistant/Massage Therapist **ALINA MILAN** is suspended **THIRTY (30) DAYS (June 17, 2013 through July 16, 2013)** for violation of California Horse Racing Board rules#1890(Possession of Contraband), #1843(c)(Medication, Drugs and Other Substances), and #1840 (Veterinary Practices and Treatments Restricted).

During the term of suspension, all licenses and license privileges of Alina Milan are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Ms. Milan is denied access to all premises in this jurisdiction.

The foregoing ruling was issued in order to finalize the agreement reached between the Board's representative, Investigator Rick Amieva, and Ms. Milan's counsel, David Jones, Esq. (Ref. 6-15-13¹)

AGUIRRE HEARING

The second day of testimony in the complaint filed against Trainer Paul Aguirre was held this morning, with testimony from Mr. Aguirre, Dr. Nicola Hardgrove, and Mr. Aguirre's wife, Lisa Aguirre. Investigator Phil Miyazaki was recalled to the witness chair and gave additional testimony. Finally, closing arguments from both sides were heard. The Stewards will review testimony and render a proposed decision to the Board shortly.

PHENYLBUTAZONE HEARING

Trainer Michael Curtis testified via telephone into a complaint filed against him for a Bute overage in one of his horses. The horse "Royal Weekend", the second place finisher in the second race at Santa Anita Park on April 12, 2013, was post race tested and came back with a level of 2.60 ug/ml. Mr. Curtis felt that the time of administration – 24 hours and 15 minutes before race time – led to the overage. Since Official Veterinarian Tim Grande recommends twenty six to twenty eight hours prior to race time it is very possible that time of administration was the culprit. Mr. Curtis has never had a violation of this type and therefore was issued a warning.

RACE REVIEW

Jockey Brice Blanc was in the office to review the seventh race from Saturday, during which his mount was responsible for interference during the stretch run. Mr. Blanc acknowledged his error and was sent away with a warning.

JOCKEY OBJECTION/NO CHANGE

The objection sign was posted after the eighth race as jockey Victor Espinoza (3rd, #3 Teddy's Promise) lodged a claim of foul against Corey Nakatani (2nd, #9 Shumoos) for interference inside the ¼ pole. Espinoza felt he had been placed in tight quarters and forced to check when Nakatani's mount altered course to the inside. After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the incident the Stewards unanimously voted to dismiss the objection. Video supported the Stewards' contention that Espinoza drove into a hole with insufficient room, thereby causing his own problem.

JANET ARMSTRONG HEARING

Trainer Janet Armstrong was in the office this morning in response to a complaint filed against her for an overage of Phenylbutazone found in her horse Lord Kitra, the winner of the fourth race at Santa Anita Park on April 19, 2013. The post-race sample showed the presence of 13.8ug/ml of the drug, far exceeding the permitted amount of 2.0ug/ml. Ms. Armstrong, who was not accompanied by counsel, said she had no idea of how the horse tested so high. The only administration, at least to her knowledge, came from a 10cc injection of Bute by Dr. Vince Baker some twenty six hours prior to post time for the race.

HRTH #031

Trainer **JANET ARMSTRONG**, who started the horse "Lord Kitra" in the fourth race at Santa Anita Park on April 19, 2013, is fined **ONE THOUSAND DOLLARS (\$1,000.00)*** for violation of California Horse Racing Board rules #1843(a)(d)(Medications, Drugs and Other Substances), #1887 (Trainer to Insure Condition of Horse) and #1844(c)(1)(Authorized Medication-Phenylbutazone in excess of permitted level-13.8 ug/ml-first offense).

RULING HRTH #030

Jockey Agent **MIKE CIANI** is fined **TWO HUNDRED DOLLARS (\$200.00)*** pursuant to California Horse Racing Board rule #1790 (Jockey Agent) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement-Irving Orozco) on June 20, 2013.

This ruling was issued after Mr. Ciani admitted that he took his rider, Irving Orozco, off of a horse trained by George Lopez after giving the trainer a 'call". Ciani opted to ride for Peter Miller.

STEWARDS' INQUIRY INTO THE START

The Stewards posted the inquiry sign after the eighth race to review the start, particularly #5 Katy's Kitty, who broke four to five lengths behind the field. After speaking with the Starter, Gary Brinson, taking into account reports from the Patrol Judges and reviewing video of the start the Stewards unanimously voted to declare the horse a "starter". Video showed that the horse caused its own problem as it whipped its head to the left just as the field was dispatched. No blame could be attributed to the assistant starter who handled the horse.
