Jockey Victor Espinoza viewed video of the sixth race from Saturday and was cautioned to ride his mounts to the wire. He stood up a couple strides prior to the finish but video was not definitive as to whether Espinoza's actions cost his mount a placing.

RULING HRTH #022

Jockey agent **JIM PEGRAM** is fined **TWO HUNDRED DOLLARS (\$200.00)*** pursuant to California Horse Racing Board rule #1790 (Jockey

Agent) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement-Corey Nakatani) on May 26, 2013.

This ruling was issued after Mr. Pegram accepted responsibility for failure to make a rider change at the proper time, causing a late jockey switch and subsequent announcement.

REFUND

A refund was ordered in the first race as #4 Awfully Lucky was off during the warm up period and was declared after examination by Racing Veterinarian Stead. There was \$19,509.74 returned due to the late declaration.

REFUND

The Stewards ordered a refund in the second race as #5 Gin Jan Lizzie failed to warm up to the satisfaction of Racing Veterinarian Stead and was declared on his advice. A total of \$23,274.46 was returned to the players.

MEDICATION HEARING

A formal hearing was held this morning into a complaint filed by the Board against trainer Paul Aguirre, whose horse "Dugan Bill", the second place finisher in the seventh race at Hollywood Park on November 8, 2012, tested positive for the Class II substances Carisoprodol and Meprobamate. Present were the Board of Stewards, Leah Gershon - the Deputy Attorney General who represented the Board, Respondent Paul Aguirre and his counsel, Roger Licht. Court Reporter Michelle Deireg recorded the testimony. It should be noted that neither the findings nor the chain of custody were challenged. Investigator Phillip Miyazaki testified as to the search of Mr. Aguirre's barn and the contents found in his medicine cabinet. Among them were unlabeled bottles of Butazolidin, Ranitidine and the drug found in the test sample, Carisoprodol. The Board's Equine Medical Director, Dr. Rick Arthur, testified as to the properties and pharmacologic effect of Carisoprodol and its metabolite, Meprobamate. Time constraints forced the hearing to a close, with a second session scheduled for June 16th.

VIDEO REVIEW

Kevin Krigger was in the office this morning to review the eighth race from Friday as he permitted his mount to drift in during the stretch run and impeded a horse which was closing on the rail. After review and discussion, it was decided to issue a warning but Mr. Krigger left with the admonishment that a future incident such as this would result in a sanction.

RULING HRTH #019 (amended)

Apprentice jockey **IRVING OROZCO**, having supplied medical documentation to verify his request for an extension to his apprentice jockey's license, is granted an extension of 250 days. Irving Orozco's apprenticeship shall terminate on February 27, 2014 at midnight, or until he has ridden his fortieth (40th) winner, whichever occurs later. The preceding ruling was issued after the Stewards recalculated the starting date of his extension to give the rider one full year from the date of this fifth winner.

ACCIDENT/INQUIRY/NO CHANGE

The inquiry sign was posted after the seventh race to review the circumstances which resulted in jockey Gary Stevens being unseated from his mount, #1 Two Blue Hens, in the first turn. After speaking with the Patrol Judges and reviewing video of the incident the Stewards unanimously voted to make no change in the original order of finish. Review showed that Stevens was unseated when his mount ducked out from under him. He walked to first aid under his own power. Accident report attached.

TRAINER OBJECTION/NO CHANGE

The objection sign was also posted after the seventh race as trainer Doug O'Neill (5th, #2 Woodys Wharf) lodged a claim of foul against jockey Mike Smith (3rd, #4 Winning Rhythm) for interference nearing the finish. After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the stretch run the Stewards unanimously voted to leave the original placings intact. While Maldonado did steady when Smith altered course to the inside, he was fifth at the time of the incident and finished in that position.
