RUBEN GOMEZ HEARINGS

Trainer Ruben Gomez was in the office this morning for a formal hearing to address two complaints filed against him by California Horse Racing Board investigators. The initial complaint was filed after his horse "Mr. River Of Dreams", the sixth place finisher in the fourth race at the Los Angeles County Fair on September 25, 2011, showed the presence of the Class 3 substance Clenbuterol in a concentration over permitted

levels(602pg.ml in blood and 65 ug/ml in urine). Mr. Gomez did not dispute the findings, but was surprised at the results as he said they ceased administration five days prior to the race. A ruling will be issued disqualifying the horse but will be simplified due to fact that the horse did not earn "purse" money and was not involved in any pari-mutuel payoffs. The second complaint involved the same horse who, during morning the soundness examination, was thought to be a gelding. Mr. Gomez said that to his knowledge the horse had never been gelded as he contact the owners/breeders who said the horse was still a colt but that the gonads did not descend from the scrotum. Under the circumstances, the complaint was dismissed.

ACCIDENT/STEWARDS' INQUIRY/NO CHANGE

The inquiry sign was posted after the fourth race to review the circumstances which resulted in jockey Martin Pedroza, aboard #10 Carol's Legacy, being unseated from his mount while leading in mid-stretch. After speaking with the Patrol Judges and reviewing video of the incident the Stewards unanimously voted to make no change in the placings. Video review showed that the two-year-old colt hand an abrupt left hand turn near the 1/8 th pole and dislodged Pedroza. The rider was on his feet shortly after the paramedics arrived and walked back to the jockeys' room. He was examined by the track physician and found to be fit to ride. Mr. Pedroza fulfilled two commitments before he became too body sore to go on. He was replaced in the final race of the day.

MINUS POOL

A minus pool of \$3,920.92 was created in the fifth race when #5 Fast Bullet, the prohibitive favorite at odds of 1-5, proved the easiest of winners.

REFUND

A refund was ordered in the ninth race as #6 Silver Street lost a left hind shoe and would not cooperate when the platers attempted to nail it back in place. The refund amounted to \$44,037.86.
