SOTO RULING

HRTH #044

Trainer **ANTONIO SOTO**, whose horse "Northern Turco" was scheduled to start in the second race at Hollywood Park Race Track on December 4, 2010, is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1845(e) (Authorized Bleeder Medication-failure to treat) pursuant to California Horse Racing Board rule #1629 (Late Declaration).

The above ruling was issued after Mr. Soto was informed of the penalty. He stated he assumed Dr. Arakjo would treat his horse and Dr. Arakjo stated he was never informed to do so which prompted the late declaration.

FILM REVIEW

Apprentice jockey Nicole Shinton, as directed by the Stewards, met to review the first race stretch run from yesterday. Ms. Shinton allowed her mount to drift outward and in the process caused a horse to her outside to also drift, creating interference for a horse behind them. She stated she was not mindful of how far she drifted. Ms. Shinton was informed she needs to be aware and make a stronger effort to maintain a straight course and her failure to do so required the following ruling:

HRTH #045

Apprentice jockey **NICOLE SHINTON** , is suspended for THREE (3) RACING DAYS (December 11, 12, and 16, 2010) for failure to make the proper effort to maintain a straight course in the stretch, causing interference while riding "Warren's Rough Luv" in the first race at Hollywood Park on December 4, 2010. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding). Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

The above ruling was issued after trainer Davidson met with the Stewards and the California bleeder medication registration process was explained.

GONZALEZ RULING

HRTH #047

Apprentice jockey **ALEX GONZALEZ** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for violation of California Horse Racing Board rules #1922 (Identification Required) and #1930 (Obedience to Security and Public Safety Officers).

The above ruling was issued after Mr. Gonzalez appeared before the Stewards concerning a security violation. Mr. Gonzalez was initially refused entry onto the backside when he was unable to produce his CHRB license. After being issued a violation notice Mr. Gonzalez unleashed profane language directed towards the security guard. Mr. Gonzalez did admit to losing his temper and assured the Stewards he will have better control in the future.

INQUIRY SECOND RACE (6 furlongs-cushion) NO CHANGE

Following the running of the race the inquiry sign was posted to review a possible infraction inside the eighth pole. Involved were # 3 Fire In The Wind (E. Maldonado 1st), # 4 Big Bad Boo (Matt Garcia 2nd) and # 6 Warren's Dove (P. Valenzuela 3rd). After a review of the videos, conversation with the Patrol Judge and all jockeys involved it was a unanimous decision to let the original order of finish stand. The # 6 horse did steady when # 3 shifted in and #4 shifted out at the same time, but the hole never closed and in the Stewards opinion the placing of # 6 was not compromised.

FILM REVIEW

Jockey Edwin A. Maldonado met with the Stewards to review the second race from yesterday (reference-12-10-2010³). Mr. Maldonado was involved in an inquiry that did not require a change in the order of the finish. The Stewards felt his mount's slight drift was quickly corrected and he was so informed.

Jockey Matt Garcia was also in to see the second race as well as the fifth. The video confirmed that Mr. Garcia made an appropriate effort to correct his horse down the lane in the second race. In the fifth race he was involved in a three horse spread entering the first turn. The horse to his inside was getting out and his mount appeared to be hard to control and

ran up between horses adding to the already tight quarters. Mr. Garcia was exonerated from any culpability in this incident.
