FILM REVIEW

Jockey ALONSO QUINONEZ came to the office to review his ride in the fourth race yesterday in which he was somewhat artful in sliding his horse out for running room turning into the stretch but allowed his horse to drift out past what was necessary to complete the maneuver without contact. He agreed with our assessment and pledged to ride more cleanly in the future.

Apprentice jockey ALEX GONZALEZ met with us this morning to review two races from yesterday's card in which we felt he could have made better choices in terms of taking too strong of hold on his mounts. While neither horse caused any interference, we tried to counsel Mr. Gonzalez that taking such strong holds was not only bad for his reputation and diminished his chances of winning, but in one of the races, made it appear as if he wasn't giving his best effort to win the race. In that particular case, we contacted the trainer after the race to ascertain his pre-race riding instructions, and are satisfied that this was a case of poor judgment and not something more nefarious. Safety steward Luis Jauregui arranged a meeting with journeyman rider David Flores to give the apprentice some advice and pointers.

Jockey FELIPE VALDEZ came to the office to discuss the fact that he took off the last race yesterday. While he claimed that he was sick, we wanted to follow up with the rider because he had a habit in the past of taking off later races with a sickness excuse.

Jockey COREY NAKATANI came to the office to review two races from yesterday's card. During the running of the fifth race, it was our opinion that the Mr. Nakatani could have maintained a straighter path as his horse was dropping back in the stretch run. He agreed. Also, films revealed that during the stretch run of the first race, Mr. Nakatani used his whip eight times on his mount, who was always in last place and never closer than ten lengths behind the next to last place horse. His mount was eventually beaten 21 lengths by the penultimate finisher. He claimed that the owner and trainer had instructed him to ride his horse in this manner and that his horse was still responding to the whipping. We found neither excuse plausible and issued the following ruling:

Jockey **COREY NAKATANI** is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1688 (Use of Whips-using whip after horse had attained its maximum placing) during the running of the first race at Hollywood Park on November 25, 2010.
