FILM REVIEW

Apprentice jockey JESUS VELAZQUEZ came to the office this evening to discuss his rides in the first and second races on Sunday. In the first race, he attempts to split horses on a horse that is visibly difficult to handle. After this move, his horse moves directly to the inside fence and causes fellow rider Joe Talamo to take up. While some of the blame could be assigned to the horse, we felt he could have done more to guide his horse. He agreed. In the second race, films shows that Mr. Velazquez's mount pulls a bit, but that he allows him to run up between horses as the main field is entering the turn. This caused Felipe Valdez aboard his rival to the inside to take up sharply to avoid going over the fence or clipping heels. Mr. Velazquez acknowledged his responsibility and was therefore not surprised when he received the following ruling:

HRTH #001

Apprentice jockey **JESUS VELAZQUEZ** is suspended for **THREE (3) RACING DAYS (November 11, 12 and 13, 2010)** for altering course without sufficient clearance, causing interference in the far turn while riding "Cork Creek" in the second race at Hollywood Park Race Track on October 31, 2010. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding).

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

Jockey BRICE BLANC came to the office this evening to review his ride in the seventh race on Sunday. His horse broke sharply and inwardly, and after a few strides causes the horses to his inside to steady. While he did make some effort to correct his mount's course, we believe his reaction should have been quicker. He agreed.

SAFETY HELMET CITATIONS

After a protracted grace period and many warnings, the new rule requiring approved safety helmets was enforced in earnest by the outriders, investigators and Safety Steward Luis Jauregui. Fortunately, almost everyone has complied and only four licensees were referred to our office. As promised on the overnight for the last month, the following rulings were issued:

HRTH #002

Exercise rider **LUIS ORTEGA** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for failure to wear an approved safety helmet while on the Hollywood Park race track on November 5, 2010. This constitutes a violation of California Horse Racing Board rule #1689 (Safety Helmets Required).

HRTH #003

Exercise rider **KARIN KISFALUDY** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for failure to wear an approved safety helmet while on the Hollywood Park race track on November 5, 2010. This constitutes a violation of California Horse Racing Board rule #1689 (Safety Helmets Required).

HRTH #004

Trainer **LINDA MIKUS** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for failure to wear an approved safety helmet while on the Hollywood Park race track on November 5, 2010. This constitutes a violation of California Horse Racing Board rule #1689 (Safety Helmets Required).

Trainer **PETER MILLER** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for failure to wear an approved safety helmet while on the Hollywood Park race track on November 5, 2010. This constitutes a violation of California Horse Racing Board rule #1689 (Safety Helmets Required).

GONZALEZ RULING

Apprentice jockey ALEX GONZALEZ came to the office this morning as directed by a security citation issued for wearing an unapproved safety helmet on the track this morning. He was issued the following ruling:

HRT# #006

Apprentice jockey **ALEX GONZALEZ** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for failure to wear an approved safety helmet while on the Hollywood Park race track on November 6, 2010. This constitutes a violation of California Horse Racing Board rule #1689 (Safety Helmets Required).

CALLAGHAN RULING

Trainer SIMON CALLAGHAN contacted the office this morning to request a scratch for his runner in the seventh race today. Apparently, he had pre-race tested his horse for procaine because he was concerned about some penicillin that the horse had received at some point prior to entry. Unfortunately, Mr. Callaghan failed to notify anyone of the possibility that the entry might be compromised and ended up keeping a horse out of the race that would have otherwise been able to run. Needless to say, when the test came back positive, his horse had to be scratched, but he was given the following penalty:

Trainer **SIMON CALLAGHAN** whose horse "Dubawi Heights" was scheduled to start in the seventh race at Hollywood Park Race Track on November 6, 2010, is fined **FOUR HUNDRED DOLLARS (\$400.00)*** for violation of California Horse Racing Board rule #1698 (Failure to Start and Run-medication administration) pursuant to California Horse Racing Board rule #1629 (Late Declaration).
