08-05-16³ **RULING #11 – IRVING OROZCO**

RULING #11

Jockey **IRVING OROZCO** who rode **SNOWY CORONITAS** in the second race at the Sonoma County Fair (Santa Rosa) on Thursday, August 4, 2016 is fined the sum of One Hundred dollars (\$100.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop – used more than three times without giving the horse a chance to respond).

The above ruling was issued after Mr. Orozco waived a hearing and admitted he violated the crop rule during the running of the second race on August 4, 2016. Mr. Orozco was observed striking his mount more than the permitted times during the quarter horse event.

08-05-16⁴ **FILM REVIEW**
 Jockey Julien Couton and the Stewards reviewed the video of the sixth race from August 4, 2016. Mr. Couton's mount was observed drifting out under left handed use of the crop and making contact with a rival. The veteran rider was warned to be more cautious with the crop on a drifting mount.

08-05-16⁵ **HORSE GOES WRONG – 8TH RACE**
 Following the running of the eighth race #2 DO U KNOW WHO I AM (Tr. Leonardo Rivera) went wrong and was pulled up by Jockey David Martin. Track Veterinarian Sara Sporer reported the three year old gelding suffered a low bowed tendon. The horse ambulance was delayed arriving to the scene. Safety Steward Richard Lewis will look into the cause of the tardiness.

08-06-16³**INQUIRY – DOUBLE DISQUALIFICATION -1ST RACE**

The Stewards posted the inquiry sign following the first race (mule) to review two separate incidents. The first issue involved #1 DASHING JACK (Juan Arriaga) (4th), #2 PENELOPE (Hugo Herrera) (6th) and #3 SHU FLY (Francisco Monroy). The video shows #1 DASHING JACK broke out at the start and impeded both #2 PENELOPE and #3 SHU FLY.

The second incident inside the 1/16 pole showed #5 PLEASE BELIEVE ME (Luis Godoy) (2nd) drift in and impede #2 PENELOPE (Hugo Herrera) and #1 DASHING JACK (Juan Arriaga).

The Stewards decided unanimously that both incidents warranted disqualification.

08-06-16⁴**ACCIDENT -1ST RACE**

Following the running of the first race the mule PLEASE BELIEVE ME unseated Jockey Luis Godoy. The ambulance responded to the scene and reported Mr. Godoy was uninjured.

08-06-16⁵**FILLY VANNED OFF – 5TH RACE**

Following the running of the fifth race #1 LADY OF TROY (Tr. Rene Amescua) was pulled up by Jockey Kyle Frey. Track Veterinarian Sara Sporer reported the filly was unsound and given a ride home in the horse ambulance.

08-06-16⁶**NON STARTER – CLAIM VOIDED – 8TH RACE**

The Stewards flashed the inquiry sign following the eighth race for a review of the start. #3 BOMBAY BOB (Catalino Martinez) left the starting gate without his rider and public address announcer Michael Wrona was directed to advise the patrons to hold all wagers on that horse.

After a thorough review and a discussion with starter Todd Stephens it was clear that BOMBAY BOB'S head was pinned behind the stall post when the field was dispatched and Jockey Martinez had stepped off his mount.

The Stewards decided unanimously to declare #3 BOMBAY BOB a non-starter and ordered a refund on all wagers that included BOMBAY BOB.

The Stewards also voided the claim submitted by Trainer O.J. Jauregui on BOMBAY BOB in accordance with California Horse Racing Board Rule #1658 (Vesting of Title to Claimed Horse).

08-07-16³**RULING #12 – JUAN ARRIAGA****RULING #12**

Jockey **JUAN ARRIAGA** who rode **DASHING JACK** in the first race at the Sonoma County Fair (Santa Rosa) on Saturday, August 6, 2016 is suspended three (3) racing days (August 14, 19 & 20, 2016) for failure to make a proper effort to maintain a straight course leaving the starting gate and causing interference resulting in the disqualification of his mount from fourth to sixth, a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The above ruling was issued after Mr. Arriaga and the Stewards reviewed the video of the first race from August 6, 2016. Mr. Arriaga noted that his mount, Dashing Jack, broke out at the start, but admitted he made little attempt at preventing the interference.

08-07-16⁴**RULING #13 – MARTIN ARRIAGA****RULING #13**

Jockey **MARTIN ARRIAGA** having failed to appear as ordered by the Board of Stewards at the Sonoma County Fair (Santa Rosa) on Friday, August 5, 2016 for film review, is hereby suspended for violation of California Horse Racing

Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of CHRB rule #1688 (Use of Riding Crop – used more than three times without giving the horse a chance to respond).

The foregoing ruling was issued as Mr. Arriaga has failed to appear as ordered by the Stewards.

RULING #14 – LUIS GODOY

RULING #14

Jockey **LUIS GODOY** who rode **PLEASE BELIEVE ME** in the first race at the Sonoma County Fair (Santa Rosa) on Saturday, August 6, 2016 is suspended five (5) racing days (August 14, 19, 20, 21 & 26, 2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to seventh, a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

This ruling issued after Mr. Godoy and the Stewards reviewed the first race from August 6, 2016. Mr. Godoy acknowledged he erred by using his crop right handed on his mount who was drifting in at the time. This is the second ruling for a riding offense issued against Mr. Godoy in the last thirty days.

INQUIRY – DISQUALIFICATION – 1ST RACE

The Stewards posted the inquiry sign following the first race to review an incident near the 3/16 pole involving #4 CRIMINETLY DUDE (Maicol Severino) second and #2 FLEUR DAMOUR (Joe Crispin) who finished sixth.

After reviewing the video and interviewing the riders involved, the Stewards decided unanimously to disqualify #4 CRIMINETLY DUDE from second to sixth for drifting into the path of #2 FLEUR DAMOUR, and forcing the latter to check sharply, lose momentum and the opportunity at a better placing.

INQUIRY – DISQUALIFICATION – 2ND RACE

The Stewards conducted an inquiry following the second race to review an incident near the 5/16 pole involving #1 SILLA'S JUSTICE (Aubrie Green) fifth and #3 TEMPTABLE (Pablo Flores) who finished sixth.

After interviewing the riders involved and reviewing the video, the Stewards decided unanimously to disqualify #1 SILLA'S JUSTICE from fifth to sixth for severely bumping and impeding #3 TAMPTABLE, preventing the opportunity at a better placing.

CLAIM VOIDED – 3RD RACE

The Stewards voided the claim submitted by Trainer John Martin for #3 I'M NOT GRAY after the state veterinarian, Don Dooley, DVM reported the six year old gelding was unsound in the right foreleg. I'M NOT GRAY was returned to the Jerry Hollendorfer barn.
