8-8-13²**CURTIN RULING (CASE 13GG082) (Ref: 8-1-13³)****RULING NO.12**

Exercise Rider **PATRICIA M. CURTIN** is hereby suspended thirty (30) days, August 12, 2013 through September 11, 2013 for violation of California Horse Racing Board rule 1890 (Possession of Contraband - Methamphetamine, Marijuana and Hypodermic Needle).

The above ruling was issued after due deliberation over last Thursday's hearing. Ms. Curtin accepted the penalty, as issued, with no argument.

8-8-13³**MIRANDA RULING****RULING NO.13**

Trainer **EFRAIN MIRANDA** is hereby fined one thousand dollars (\$1000.00) * for failure to properly report the gelding of the horse MI AGAVE which started in the sixth race on July 12, 2013 at the California State Fair (Sacramento); a violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

The above ruling was issued after Mr. Miranda accepted responsibility for failure to inform the Racing Office of the castration of "MI AGAVE."

Friday8-9-13¹**ORTIZ RULING****RULING NO.14**

Trainer **ADOLFO C. ORTIZ** who was scheduled to start "FISHERS WISDOM" and "TROUBLE MAKING FIRE" in the second race on August 8, 2013 at the Sonoma County Fair, Santa Rosa, is hereby fined four hundred dollars (\$400.00)* for failure to secure Worker's Compensation Insurance, resulting in late declarations; a violation of California Horse Racing Board rule #1501 (Workers Compensation Insurance Required) pursuant to CHRB rule 1629 (Penalty for Late Declaration).

The above ruling was issued after Mr. Ortiz was contacted about his lack of insurance causing two late scratches. Mr. Ortiz blamed State Fund for not honoring a business check for his insurance. The problem was rectified today, but the policy won't take effect until Monday, August 12, 2013.

8-9-13²**DeLIMA RULING****RULING NO.15**

Trainer **CLIFFORD DeLIMA** who started "TIZ BLUSHING" in the 3rd race on Wednesday August 7, 2013 at the Sonoma County Fair is fined one hundred dollars (\$100.00)* for failure to report an equipment change in the proper manner. A violation of California Horse Racing Board rule #1553 (Duties of Paddock Judge – no change of equipment without the consent of the Stewards).

The above ruling was issued after Mr. DeLima was contacted and took responsibility for mixing up the blinkers on two horses he was saddling in the same race.

8-9-13³**DeMARCO HEARING – CASE 13GG0068****RULING NO.16**

Owner **ANTHONY DeMARCO** is fined one hundred dollars (\$100.00) * for violation of California Horse Racing Board rule #1482 (Employment of Unlicensed Person).

The above ruling was issued following a hearing this morning. Mr. DeMarco had unwittingly employed a suspended licensee to care for his horses while he was in Arizona preparing to come to California. Mr. DeMarco accepted the penalty and understood his responsibility in the matter.

8-9-13⁴**VIDEO PROBLEMS**

Simulcast video was reported to be inoperative from approximately fifteen (15) minutes to post for the 1st race until after the 3rd race. TVG did have the signal from Del Mar to Santa Rosa.

8-9-13⁵**INQUIRY 4th RACE – NO CHANGE**

The inquiry sign was posted to review the start of today's 4th race concerning #4 "ROSIE KYLE" (6th – Jockey Pedro Terrero) and #5 "KOOL LUCY" (8th – Jockey Kyle Frey). After review it was determined that #5 broke very slowly and that although #4 broke out into #5's path the incident had no bearing on the outcome.

Trainer **ROBERT TROEGER** is fined one hundred dollars (\$100.00) * for violation of California Horse Racing Board rule #1482 (Employment of Unlicensed Person).

The above ruling was issued after Mr. Troeger was contacted and admitted to having an unlicensed person in his barn.

8-10-13²**FUN TIMES**

The 2nd Annual Jockey Foot Race was conducted between the 1st and 2nd races today.

Twelve of our reinsmen lined up in the starting gate and were dispatched by honorary Starter Russell Baze for the approximately one hundred yard dash. Jockey Luis Lira blew the competition away with a time of 11.24 seconds.

8-10-13³**2nd RACE INQUIRY – DISQUALIFICATION**

The inquiry sign was posted to review the running of the 2nd race. After review it was determined #5 JACKSON'S DREAM (Jockey – Luis Lira, 2nd) lugged in throughout the race interfering with numerous competitors. The worst affected were #4 MY ALLOW-ANCE (Jockey – Luis Langorica, 3rd) and #1 OUTA IDAHO (Jockey – Martin Arriaga, 7th) whose jockeys had to check sharply at two points during the race. #5 was unani-mously placed last (7th) for the interference. Jockey Lira was held blameless as he made every effort to try and keep JACKSON'S DREAM on a straight path.

8-10-13⁴**RIDER DOWN – 2nd RACE MULE**

#3 STOCKYARD ELLIE started bucking shortly after the finish of this 350 yard mule event unseating Jockey Freddy Rodriguez. Rodriguez was on his feet after the inci-dent, but was transported to the hospital by ambulance for observation. An accident report will be attached to these minutes.
