07-25-07³ **INTOXICATION CASE** (Case # 07GG072)

Groom **KENNETH OLSEN** was cited for paddocking horse #7, SLOW MODUS in the fourth race on July 13, 2007, while intoxicated.

Mr. Olsen appeared and stated that he was attending Winners Foundation meetings. He took full responsibility for his actions. The following ruling was issued.

RULING NO. 9

Groom **KENNETH OLSEN** is fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct - Intoxication) on July 13, 2007 at the Solano County Fair.

07-25-07⁴ **RIDERS REVIEW FILMS**

Mr. **Emanuel Ramirez** appeared to discuss his ride on #5 TSETSE FLY in the second race on Monday, July 23, 2007.

Mr. Ramirez's mount bumped #6 at the ¼ pole. He was counseled to control his mount with his reins, rather than his stick.

Mr. **Jorge Herrera** appeared to discuss his ride on #2 ALPARAPASSION in the tenth race on Monday, July 23, 2007.

Mr. Herrera's mount drifted in a hit the rail at the 1/8 pole. The stewards warned him to be aware of how close he was to the rail during races.

07-25-07⁵ **INQUIRY / OBJECTION - DISQUALIFICATION - First Race**

The stewards illuminated the inquiry sign to review an incident that occurred near the wire in the mule race.

There was a trainer's claim of foul of #5 ROCKY CHIC (J. Arriaga) against #3 CHINOOK PASS (Agustin Vallejo), and a jockey's claim of foul of #5 against #3 and #6 JET SETTER (Robert Boyce).

Nearing the wire, #3 CHINOOK PASS lugged out, taking the paths of #4 BLACK VELVET and #5 ROCKY CHIC, costing #4 and #5 stride, ground and position. Because #3 cost #4 and #5 opportunities at better placings, #3 was disqualified and placed fifth, behind #5.

Original order of finish: (3) - 6 - 4 - 1 - 5 - 7 - 2

Official order of finish: 6 - 4 - 1 - 5 - (3) - 7 - 2

07-25-07⁶ **INQUIRY - DISQUALIFICATION - Second Race**

The stewards lit the inquiry sign after Race 2, an Arabian race, in order to review two separate incidents involving #5 TIKITOMA (Angel Felix).

Approaching the 3/16 pole, #5 shifted inward into the path of #1 KUGEL DE SOI (Rodrigo Matias),

forcing #1 to clip heels and stumble, losing stride, ground and position.

Passing the 3/16th pole, #5 shifts out sharply, taking the path of #4 DOUBLE FOUR (Otto Arriaga), forcing the rider of #4 to check sharply and lose stride, ground and position.

Because #5 interfered with both #1 and #4, costing them both opportunities at better placings, #5 was disqualified from third and placed seventh.

Original order of finish: 7 - 6 - (5) - 8 - 1 - 3 - 4 - 2

Official order of finish: 7 - 6 - 8 - 1 - 3 - 4 - (5) - 2

07-25-07⁷ **BREAKDOWN - Third Race**

On the backstretch during Race 3 for Thoroughbred fillies and mares, #8 SAGE went wrong on her right front. She was pulled up near the ½ mile pole with a possible injury to her sesamoids.

07-25-07⁸ **INQUIRY - DISQUALIFICATION - Seventh Race**

The stewards lit the inquiry sign after Race 7 in order to review two incidents that occurred in the stretch.

Inside the 1/16 pole #7, GIANTS' COOL CAT (Carlos Silva), raced on the rail. #7 shifted out, taking the path of #6 KATHERINE R.N. (David Lopez), bumping #6 into the rear end of #5 to their outside. The rider of #6 was forced to check, losing stride, ground and position.

Then, nearing the wire, #7 came out again, impeding #5 LAKE DREAM (Russell Baze), forcing #5 to check and lose stride, ground and position.

#7 cost #6 and #5 chances at better placings and was thus disqualified from second to eighth, behind #6.

07-26-07³**RIDERS REVIEW FILMS**

Jockey **Carlos Silva** appeared to discuss his ride in Race 7 on Wednesday, July 26th, on #7 GIANTS' COOL CAT. In that race he shifted out at the 1/16 pole, taking the path of #6 and bumping #6 into the path of #5, to their outside. Also, nearing the wire #7 came out again, impeding #5 and forcing #5 to check.

Mr. Silva failed to maintain a straight course in the stretch and caused interference. He accepted criticism and awaits a penalty with good grace. Ruling to follow.

Jockey **Alvaro Rojas** arrived to review his ride on Wednesday, July 25th in the third race on #2, HOLA MAMACITA. Mr. Rojas allowed his mount to cross over and take the path of #4, SAIL ON SUNSHINE, nearing the wire. Mr. Rojas recognized his mistake and will be more careful in the future.

Jockey **Agustin Vallejo** arrived to explain his absence before the first race on Wednesday. Mr. Vallejo has been late in the past and has been warned that he must call in promptly if he is late or ill. Ruling to follow.

Jockey **Angel Felix** appeared to review his ride in Wednesday's second race on #5 TIKITOMA. Approaching the 3/16 pole, #5 shifted inward into the path of #1, causing #1 to clip heels and stumble. Also, passing the 3/16 pole, #5 shifted out sharply, taking the path of #4, forcing #4 to check sharply.

Mr. Felix maintained an erratic course around the turn and failed to maintain a straight course in the stretch, causing interference. The following ruling was issued.

RULING NO. 10

Jockey **ANGEL FELIX**, who rode TIKITOMA in the second race at the Sonoma County Fair (Santa Rosa) on July 25, 2007, is hereby suspended three (3) racing days (August 2, 3 and 4, 2007) for altering his course without sufficient clearance and causing interference, resulting in the disqualification of his mount from third to seventh position – a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

Mr. **Otto Arriaga** appeared to review his ride on Wednesday in the first race on #3, CHINOOK PASS. Nearing the wire #3 lugged out, taking the path of #4 and #5.

Mr. Arriaga did appear to use his left rein and was whipping right handed, however, the stewards noted the mule straightened after the wire, once Mr. Arriaga stopped using the stick.

The stewards suggested that Mr. Arriaga concentrate on using his reins and consider not whipping mules if similar circumstances arise in the future.

The following rulings were issued:

RULING NO. 11

Jockey **CARLOS SILVA**, who rode **GIANTS' COOL CAT** in the seventh race at the Sonoma County Fair (Santa Rosa) on July 25, 2007, is hereby suspended three (3) racing days (August 2, 3 and 4, 2007) for altering his course without sufficient clearance and causing interference, resulting in the disqualification of his mount from second to eighth position - a violation of California Horse Racing Board rule #1699 (Riding Rules - careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

RULING NO. 12

Jockey **AGUSTIN VALLEJO** is fined one hundred dollars (\$100.00) for failure to fulfill his riding obligation in the first race on Wednesday, July 25, 2007 - a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

07-26-07⁴ **ASSOCIATION REQUEST**

Wine Country Racing Association (Santa Rosa) contacted the stewards to request permission to have no show wagering on a mule race scheduled for Saturday, July 28, 2007.

The well known mule SARA NELSON was scheduled to start and the Association was concerned that a large minus show pool could result.

California Horse Racing Board Executive Director Ingrid Fermin was contacted regarding the request.

The Association request was granted by the Executive Director because such a prohibitive favorite would most likely result in a significant minus pool.

07-28-07³ **NEW TRACK RECORD**

The running time of Race 1, for mules, three and up, was of special note. The time of 22.39 for 400 yards set by #2 BAR J F TICKET, was a new track and world record.

07-28-07⁴ **SECOND RACE - BREAKDOWN**

During the second race for Quarter Horses going 350 yards, #4 OH WHAT A MEMORY went wrong in mid-stretch and was pulled up by rider Daniel Boag.

#4 was vanned off with a possible muscle injury to his left hind.

07-28-07⁵ **INQUIRY - DISQUALIFICATION - Seventh Race**

The stewards illuminated the inquiry sign after Race 7 in order to review two separate incidents in the stretch.

At approximately the 3/16 pole, #7 KING OF FRESNO (Pedro Flores) came in, bumping and impeding #3 HOLD THE PEACE (Alex Bisono) costing him stride, ground and position.

Again, just past the 1/8 pole #7 came in, making contact with #3, shifting his rival off his path.

#7 finished second, a very short whisker ahead of #3. Because #7 interfered with #3 and cost #3 a chance at a better placing, #7 was disqualified from second and placed third behind #3.

07-28-07⁶ **INQUIRY - DISQUALIFICATION - Ninth Race**

The stewards lit the inquiry sign after Race 9 to review an incident in the stretch. Inside the 3/16 pole, #4 LAST CONQUEST (Jorge Ayarza) drifted in, bumping and taking the path of #1, R. SPRING AFFAIR (Russell Baze). #1 was forced to check sharply, losing stride, ground and position. #4 cost #1 a chance at a better placing and was thus disqualified from fourth and placed behind #1 in seventh position.

Rider **Pedro Flores** appeared to review his ride in Race 7 on Saturday on #7 KING OF FRESNO. Mr. Flores allowed his mount to drift in and make contact with #3 once at the 3/16 and once after the 1/8 pole during the stretch run.

Mr. Flores made a reasonable effort to correct his mount and stopped using his stick after each incident of contact. Mr. Flores will be even more vigilant in the future.

Jockey **Jorge Ayarza** appeared with agent Raul Cespedes to review his ride on #4, LAST CONQUEST, in Saturday's ninth race. Mr. Ayarza's mount bore in at the head of the stretch, taking the path of #1 R. SPRING AFFAIR on the rail.

Mr. Ayarza corrected his mount promptly and also pointed out that his horse was wearing a full cup blinker over his outside eye, perhaps encouraging the horse to lug in.

The stewards commended Mr. Ayarza's efforts.

07-29-07⁴ **TRAINERS OBJECTION - NO CHANGE - Second Race**

The stewards illuminated the inquiry sign to review Race 2, a mule race, after a trainer's objection was called.

Sue Andros, trainer of #6 ROCKY CHIC, claimed an objection against #5 BAR J F BOLD THUNDER and #7 R/R CHARLIES SECRET.

The video tape failed to substantiate the trainer's claim of foul. Although the #7 did cross the path of #6, the #7 was clear when he did. The #6 broke a step late and raced greenly throughout.

Jockey Agustin Vallejo contacted the stewards via telephone to discuss his failure to fulfill a riding obligation on Friday, July 27, 2007. He waived his right to a hearing, thus the following ruling was issued:

Jockey **AGUSTIN VALLEJO** is fined the sum of three hundred dollars (\$300.00) for failure to fulfill his riding obligation in the first race on Friday, July 27, 2007 – a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement – repeated offenses).

07-30-07⁴ **RIDERS REVIEW FILMS**

Jockey Robert Boyce appeared to discuss his ride on July 27, 2007, in the first race on the #5 mule, BAR JF FLYIN J.

The mule bolted to the outside during the running of the race and looked as if it was going over the outside fence.

Mr. Boyce attempted to correct the mule and as a last resort, struck him on the muzzle with his stick.

Mr. Boyce acted in desperation, however he was reminded that the events took place in public view.

The mule was placed on the steward's list.

07-30-07⁵ **MAIN TRACK RAIL DAMAGED**

During the moving of the starting gate before the ninth race, the gate struck the inside rail of the main track just before the 3/16 pole.

Fortunately the gate itself sustained only minor damage and the ninth race was scheduled on the turf.

The ninth race went off after a minor delay to repair the gate, and the inside rail of the main track was repaired before the main track was renovated for the tenth race.
